### FORD IS READY— PINCKNEY ISN'T

Henry Ford visited Pinckney Saturday to inspect the work that has been done on his dam and noted how well the dam has stood since rebuilding and with the added pressure of the higher water level.

In conversation with J. C. Dinkel, who has sold some Pinckney property to Mr. Ford, the latter stated that he was very highly pleased with the Pinckney water power and that he was at work designing a special caterpillar dredge to deepen the creek east of the mill two feet and straighten it through his property to the Dexter road, nearly a half-mile.

Mr. Ford stated that the machine would be ready to start work as soon as warmer weather made conditions favorable and that the work would be rushed through. He was informed by Mr. Dinkel that one or two options had as yet not been taken up on account of the abstracts of title not being ready.

Mr. Ford had not been aware of these conditions, but supposed the matter had been arranged.

So that now it seems that all that can prevent work on the Ford project going ahead early this spring is the deciding over of a small piece of the land already covered by options. Surely nobody in Pinckney wishes any further delay so, no doubt, this small matter will be straightened out at once.

### ORDERED DISCHARGED

John Bezak and Joe Pusta who live about 1-2 miles west of town appeared for trial before Judge Collins in the circuit court Monday and pleaded not guilty to the charge of violating the state prohibition law.

They were arrested at their home some time ago and a still and quantity of liquor was taken with them.

Their attorney L. E. Howlett, pointed out to Judge Collins that the warrant issued was faulty as it was issued without sufficient evidence. Judge Collins, after a delay investigating this new legal angle, decided that the point was well taken, ordered the prisoners discharged, and according to those who were there, ordered that the alleged booze and paraphernalia for its manufacture should be returned to the accused.

Trifon Pian, who lives about a mile north of Pinckney was next arraigned and he too was released for insufficient evidence.

Pian claims that an old broken still, or rather, parts of one, a hog feed cooker and a quart of whiskey bought in Detroit, belonging to someone else was all the evidence against him. He said the parts of the still were left there by tenants who left the farm two or three years ago, and that the cooker was only used for the hog feed. He alleges spite was the cause of his arrest, and that his premises had been searched before.

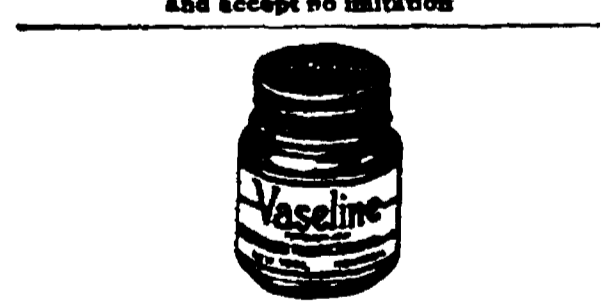

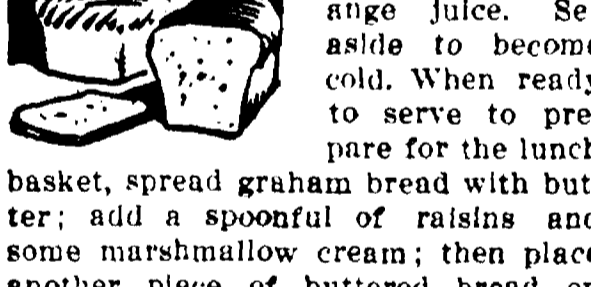
Boston Prune Pie—Soak one pound of prunes in water to cover over night. Stew them in the same water until tender. Remove the stones and rub the fruit through a strainer, flavor with grated orange rind and orange juice.

basket, spread graham bread with butter; add a spoonful of raisins and some marshmallow cream; then place another piece of buttered bread on top. Cream and a nut may be used for garnishing if desired.

Potato Nut Cake—Take three-fourths cupfuls of sugar, four well-beaten eggs, one cupful of cold mashed potato, one-half cupful of grated sweet chocolate, one-half cupful of milk, one cupful of chopped nuts, two and one-half cupfuls of flour, two and one-half teaspoonfuls of baking powder and one teaspoonful of cinnamon.

Pickled Fish—Cut fish in pieces as for frying. Wash well and sprinkle with salt and let stand 12 hours, then boil about five minutes. Take one cupful of vinegar, one cupful of water, add three bay leaves and a few pepper corns tied in a small cloth. Place the fish in a stone jar and cover with the boiling hot vinegar and set away in a cool place. Add a slice of onion and a few cloves before using.

Apple Marshmallow Dessert—Peel, quarter and slice six nice juicy apples. Have ready one-third of a cupful of seedless raisins, one cupful of sugar. Arrange the apples and raisins with the sugar in layers in a buttered baking dish; add one-fourth of a cupful of water; cover and bake in a moderate oven until the apples are tender.

Chicken Cooked in Milk—Cut up a chicken as for frying—one too old to cook in the usual way will be tender if cooked in milk. Cover with sweet milk and set into a moderate oven, cook slowly, then uncover the last hour of cooking to brown the fowl.

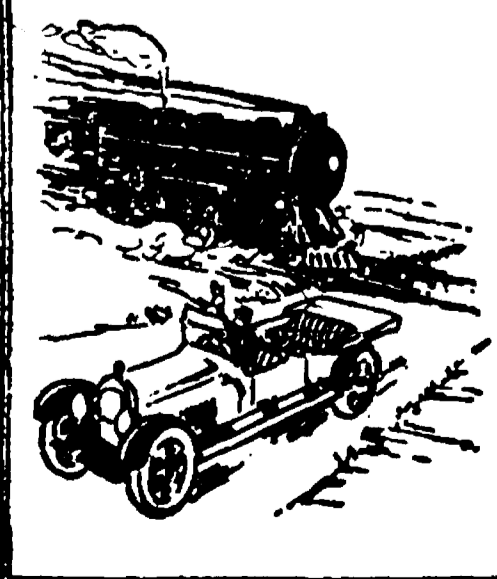

### WARNING AGAINST COLDS AND PNEUMONIA

Pneumonia is the disease to be watched out for most carefully at the present time, warns the state department of health.

During the first 24 days of February 648 cases of pneumonia were reported throughout the state, compared to 519 during the corresponding period last year and an average of 498 for the past ten years. In January 759 cases were reported, an increase of 165 cases over January 1921, and nearly twice the average for the month.

"To avoid pneumonia," advises Dr. Olin, "avoid colds and exposure to sickness. The organism causing acute lobar pneumonia is always ready at this time of year, waiting until we are at a low ebb physically for a chance to invade and lay waste the body's fortification. Other forms of the disease, the broncho-pneumonias or secondary infections are the moping up squad of neglected colds and common sicknesses."

If a person contracts a cold, it should never be regarded contemptuously. The individual who is really "not quite well" will conserve time and health by complete relaxation and rest. In fact, a thorough rest indulged in early enough may prevent pneumonia. Even if pneumonia does develop, the rest will have helped to conserve the body's resistance, every ounce of which will be needed before the patient recovers.

Finally, dress to suit the thermometer, and not the calendar; eat heartily and wisely; sleep with the windows open, ventilate the house several times daily.

### EIGHTEEN-FOOT BRIDGES ON FEDERAL AID ROADS

Few highway bridges with a width of roadway less than 18 feet are now being constructed on improved roads, according to engineers of the Bureau of Public Roads of the United States Department of Agriculture. In the past some of 12 feet and good many of 16-foot width have been constructed in an effort to economize, but it has proved short-sighted economy. Only one line of traffic can pass over a 12-foot roadway and 16 feet of width will not accommodate two lines in safety. Many of the States such as Pennsylvania, New Jersey, Ohio, and Massachusetts have found it advisable in replacing old bridges on important roads to make them wide enough to accommodate three and four lines of traffic.

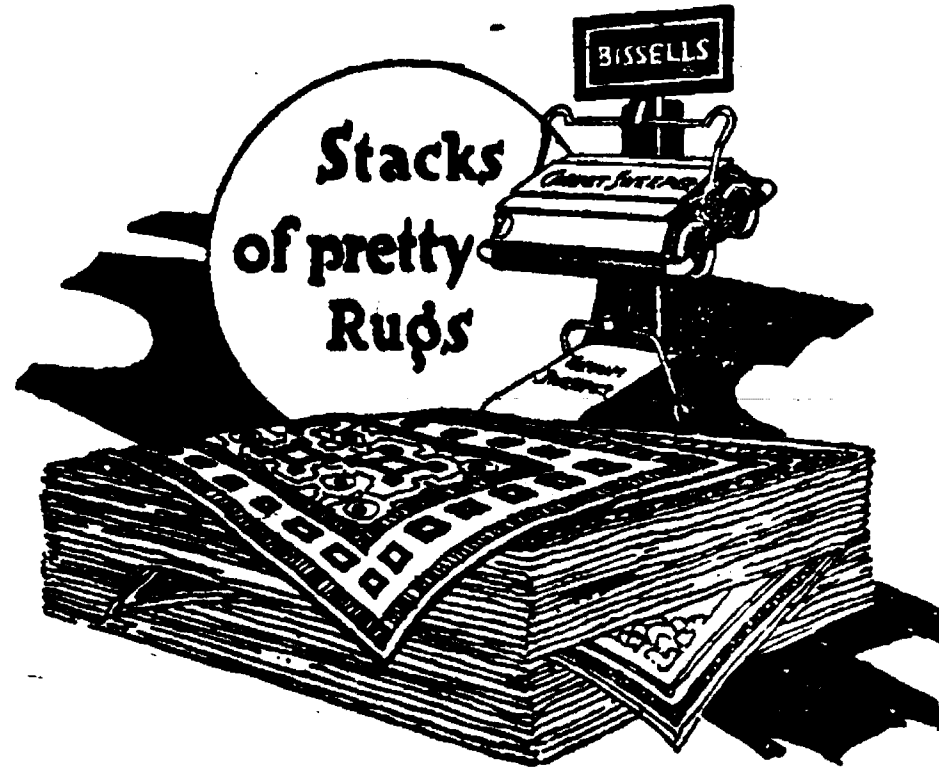
