HUNTING IN MICHIGAN TO CLOSE DECEMBER 31

With but two exceptions, hunting in the woods and on the waters in Michigan will come to a close until next fall, at sunset, December 31st. The badge may be caught until Feb. 1, and the rabbit may be killed in the upper peninsula until January 31st.

Whether any section of the state will be open to beaver trapping during the winter or spring it still to be decided by the Conservation Commission.

The muskrat and duck seasons throughout the state and the rabbit season in the lower peninsula will close on December 31. With the close of the duck season, the seasons on geese, brant, wild turkeys and coot close.

The trapping season for raccoons closes in the lower peninsula, December 15. The trapping season also closes December 15.

It is necessary within five days after the close of the various seasons for taking furbearing animals, for persons having raw hides of protected furbearing animals at the close of the season to make a report to the Director of Conservation, stating the kind and number of hides in his possession.

It is also the duty of any person selling hides to report to the Director of Conservation the name and address of the person to whom such hides were sold and the kind and number of hides sold.



POSTMASTER URGES

EARLY MAILING

As the time is rapidly approaching the Christmas rush in the postoffice when the volume of mail is unusually heavy, it is suggested that you and your family be prompt in mailing their Christmas mail, so that their destination before Christmas, I am taking the liberty to offer a few Christmas mailing suggestions, which should be of benefit not only to the patrons but also to the postmaster and his associates, due to the fact, that by the patrons following the suggestions offered as far as possible, more efficient service can be given and less confusion result, and this is the desire of every postal employee. Due to the fact that, during the holiday rush, it takes from two to four times the regular time for Christmas packages to reach their destination, they may be endorsed, "Please do not open until Christmas," and mailed early, that they may as far as possible, avoid the usual congestion of mails and the necessary delay of the delivery of the same. All parcels, if possible, should be packed in cardboard boxes wrapped with strong paper and tied with cord of sufficient strength to allow the package to be handled by the same. If you wish to wrap the package with "Christmas paper," first wrap with heavy paper, and return address thereon and placing over the covering of Christmas paper. By so doing if the covering of the lighter paper is torn off by handling the address can still be found on the inner wrapping paper of heavy paper. If the package is fragile or perishable give that information to the postal employee attending you in order that the same may be indorsed and handled accordingly. Always "insure" your packages, it may cause extra work for the postal employee, but we are all anxious to serve you thus, as by insuring your package, you are guaranteed safe delivery of the same. Always place the address on the lower right hand corner of the package with your return address in the upper left hand corner of the same. Last winter during a test with a package bearing the addresses contrary to the above suggestion it was returned 3 times, at which time it was readressed in order to secure delivery of the same.

If you wish to hasten the delivery of your Christmas package you may do so by "Special Delivery Service." Under the new ruling of the department, special delivery service includes special handling service, i. e. the same treatment as accorded first class mail. To the patrons mailing Christmas cards in quantity, I would suggest that they be mailed at least two weeks before Christmas in order that they may be delivered before Christmas. Any information not contained in the above suggestions will be cheerfully given you by the postoffice force or rural carriers.

CALLS ON RED CROSS INCREASE; RESPONSE TO ROLL CALL URGED

Society's Activities Reach Millions Each Year—Chairman Payne Asks Generous Support in Membership.

Disaster relief work, service to disabled veterans and their families, public health work and its many other activities caused expenditures of \$11,064,000 by the American Red Cross for the year ended June 30, 1929, according to the annual report of the organization.

This work by the Red Cross is supported by the annual Roll Call for members, which is held from Armistice Day to Thanksgiving Day, November 11 to 23.

Directing attention to the heavy expenditures by the Red Cross during the past year, and to the fact that the organization was called upon for assistance in 120 disasters in the United States and its insular possessions, Judge John Barton Payne, the chairman, said:

"The Red Cross is a volunteer society, supported by its membership, and belongs to all of the citizens. While it is a semi-governmental agency in that the President of the United States is its president, and one third of its governing board are representatives of Government departments, yet it receives no financial support from the Government.

"Funds for our work for war veterans and their families, for carrying on disaster relief, for our varied health activities, the life saving and first aid work and our many other activities, all are derived from the membership fee. The public is asked only once each year—at the Annual Roll Call—to join in this support of the Red Cross."

The Red Cross expended an average of \$926,000 per year in the past seven years, in disaster relief work from its own treasury, statements show. The work for world war veterans also has caused heavy expenditures.

HEALTH PRESERVATION IS AIM OF RED CROSS

Society Employs Rural Public Health Nurses—Teaches First Aid and Life Saving.

A comprehensive, nation-wide program to prevent illness, and to save lives through proper nursing care and advanced methods of life saving and first aid is fostered by the American Red Cross.

The organization is the largest employer of rural public health nurses in the United States, through its Chapters. The policy of the Red Cross is to encourage its Chapters to extend the public health nursing service, where leadership in this field is not taken by some other agency in the community.

The Red Cross health and life saving campaign embraces the following: preservation of health through skilled nursing care; prevention of loss of life in accidents; prevention of illness through cleanliness in the home and knowledge of methods of home care of the sick and raising the standard of health and physical efficiency through proper nutrition.

During the year just closed, more than 42,000 certificates have been issued in the Red Cross course in Home Hygiene and Care of the Sick, and since the courses were inaugurated more than 500,000 persons have been taught; 149,000 children were instructed in proper eating through the Nutrition course; 48,898 individuals passed the severe Red Cross tests in Life Saving and 52,596 persons passed the rigid examinations in the First Aid Course.

This work is supported from funds obtained in the annual Roll Call, Armistice Day to Thanksgiving Day, November 11 to 23.

SIX MILLION CHILDREN IN JUNIOR RED CROSS

The year 1929 marks the tenth anniversary of the founding of the American Junior Red Cross. There are now Junior Red Cross societies in fifty-one nations, all pledged in the common cause of service to their fellows.

Membership in the American Junior Red Cross in the United States and insular possessions is 8,878,000, and is largely through grade and high schools and private schools. The organization is governed by the boys and girls. One of its chief features is conduct of international correspondence with schools of other nations, through exchange of albums and small gifts. The American Juniors sent 25,400 Christmas boxes of small gifts to children of many nations last year.

The American Junior Red Cross gained 240,171 in membership last year.

Thirty-one nations belong to the League of Red Cross Societies, and are prepared to carry on health, disaster relief and life saving programs.

CURRENT COMMENT

Detroit apers are making much ado over the fact that two negroes were refused membership to the fashionable Bethel Evangelical church there on the West Grand Blvd. This is only the old race question bobbing up. It is only in recent years that this question has come to be a serious one in Michigan's metropolis. For years a majority of Detroit's colored people lived on Antoine, Brush and other streets leading to the river on the east side. Just before the World War and immediately afterward thousands of negroes flocked into Detroit drawn by high wages and better living conditions. Then began a real problem. To people in this section where a negro has not lived in some ten years this is hard to understand. The incoming colored hords found the east side black belt overcrowded and looked about for new quarters. They managed to get a foothold in that section just west of the West Grand Blvd. bounded on the south by Warren Ave. This section then was just building up. As the negroes moved in the white value declined. Eventually the section bounded on the east by the West Grand Blvd., on the south by Warren Ave., on the north by Tireman and on the West by Epworth Blvd. came to be regarded as the west side black belt. The property owners outside these boundaries resisted strenuously every effort of the colored people to extend their boundaries. Riots were numerous and in one a colored man, Dr. Turner, was stoned from a fashionable district north of Tireman by a mob of 1000 people. Other riots occurred and one man was shot by negroes. They were tried for murder and acquitted, being defended by the celebrated Clarence Darrow of Chicago. The fact that the Bethel Evangelical church is located on the eastern boundary is significant. The colored people are guaranteed civil and political equality but social and fraternal equality are seemingly impossible.

Indian Meets Indian



When Princess Wataasa, the Indian health teacher of the Michigan Tuberculosis Association, visited the orphanage for Indian children at Baraga, she was given a royal welcome by the youngsters, who dressed themselves in tribal costume for the occasion. Her legendary Indian tales, needless to say, were listened to with more than usual interest by the one hundred children who live at the orphanage.

Princess Wataasa entertains children with her stories, dolls, and trinkets, but she also instructs them. That her health lessons are remembered and followed is shown by the following note from one of her listeners:

"I am trying to follow your health rules so I may be a strong, healthy girl. I am 28 pounds underweight. I sleep at night with my window open.

I eat vegetables two times a day. I do not play out of doors much, but I have since you talked to our school. You have helped me and not only me but every boy and girl of our school."

From January 1 to November 15 of this year, Wataasa appeared before more than 80,000 grade and high school children. Funds raised in the sale of tuberculosis Christmas seals finance her expenses.

First Seal Buyer

Mrs. Mary Bosschem, Irons, again wins the honor of being the first person in Michigan to buy an allotment of tuberculosis Christmas seals.



Continuing a tradition that now dates back four years, she mailed to the Michigan Tuberculosis Association on Armistice Day a check for one hundred of the health stickers.

In a letter accompanying her 1929 remittance, Mrs. Bosschem wrote: "Your work is a most deserving one and I feel that it merits everybody's support. I hope you are as successful in the future as you have been in the past in carrying on your campaign against tuberculosis."

Another early Christmas seal buyer this year was George Pearson, Grindstone City, whose letter was received by the Michigan Tuberculosis Association one day after Mrs. Bosschem's. Thanksgiving Day marked the official start of the seal sale.

Seals Delivered By Air



Michigan school children who each December join in the campaign to sell tuberculosis Christmas seals were given the unusual experience this year of having a quantity of their seals "air delivered" by the plane pictured above. Seals were delivered by Pilot Ford Bott and a representative of the Michigan Tuberculosis Association to more than 50 towns in the course of a three-day, 1,500-mile trip shortly after the opening of the seal sale on Thanksgiving Day.

The airship, displaying the double-barred cross, symbol of the crusade against tuberculosis, made one trip to the Thumb region, a second to the northern part of the Lower Peninsula, and a third to the southern portion of the state. The pilot's services and use of the plane were donated by the Foster Airways Corporation as the company's contribution to the 1929 Christmas seal sale.

Since greatest emphasis is now being placed on prevention of tuberculosis through health work among chil-



MORE DEER SHOT THIS YEAR
There was from 2,000 to 4,000 more deer shot this year in Michigan than last year according to a report published by the State Conservation Department. The number of deer transported across the straits was 6,314 as compared to 5,255 a year ago. Deer shot in the lower peninsula and those kept in the upper peninsula raise the total to 10,000 or more it was estimated. No accurate count can be made. 90 bear were also taken from the upper to the lower peninsula.

PENALTIES OF HUNTERS

TOTAL \$11,456 NOV. 1

During the year ending November 1, the Game Fund of the Department of Conservation was enriched by \$11,456.29 from the sale of property confiscated by the Law Enforcement Division of the Department.

Most of the confiscated property sold by the department included furs and guns.

Listed by months, revenue from the sale of confiscated property was: November, \$1,050.50; December, \$945.25; January, \$1,890.59; February, \$2,197.62; March, \$1,329.11; April, \$420.50; May, \$1,067.22; June, \$1,251.00; July, \$129.79; August, \$81.50; September, \$154.12; October, \$839.09.

During the year ending November 1, the department confiscated 644 guns, all of which were sold. In addition a large quantity of furs were disposed of. Many traps were sold. Most of wild animals illegally killed and fish illegally caught and confiscated were given to charitable and state institutions.

Guns and furs sold at the department offices at Lansing. The original owner of a gun is given 30 days in which to purchase his gun back from the state. If he fails to do this within the limited time, the gun is sold at a price fixed by the department.

Several automobiles confiscated by the department will be sold at public auction.

NEW FIELD AIDS

OIL TAX RETURN
Increased oil production, due to the discovery of the Mt. Pleasant field, has brought an increase in revenue that will be of little aid to the state, but of considerable help to townships and counties, according to a report issued today by the state tax commission. The report covers the first

five months of the new severance tax on oil and gas.

In its frantic search for revenue to meet the \$22,000,000 construction program sponsored by Governor Fred W. Green, the last legislature hit upon the plan of taxing the state's newest industry. It was agreed that a 2 per cent tax on the value of all oil and gas produced would be equitable but the townships and counties demanded a part of the proceeds.

Distribution of Revenue
The statute passed provided that 40 per cent of the tax collected should go to the township in which the oil or gas is produced, 20 per cent to the county and the remaining 40 per cent to the state.

The law became effective toward the close of April and in that month and in May a total of \$5,919 was received. The proceeds in June jumped to \$9,064, according to the receipts it totalled \$18,325 and in September a total of \$19,236 was paid into the treasury to be distributed on the pro-rata basis.

The report estimates that at the present development of the industry the monthly receipts will increase slightly, hovering not far above \$20,000 a month for the next year. If the tax produces an average of \$20,000, the state will receive \$8,000, the townships a like sum and the counties \$4,000. This money will not go far toward state expenses but will be of substantial aid to the local territories.

The September receipts were based on a production value of \$961,569. Nearly all of this was oil as very little gas is being sold for commercial uses. What little gas there is at the present time is in the Muskegon field. There is no gas in commercial quantities in

the Mt. Pleasant field. Grand Rapids Chronicle.
