CHARLES CARROL IS

FOUND DEAD

Charles Carrol who has been living on the Orla Jackson farm about 1 mile south east of town on the Dexter road, now owned by Sam Lapham, was found dead in the farm house there about noon Sunday. Mr. Carrol was a dog fancier and was caring for several dogs belonging to Pinckney resident Carl Sykes who had a dog there about with food for it about noon Sunday. He found Carrol lying upon the couch in the living room. He had evidently died sometime during the night. Mr. Sykes notified the authorities and Coroner Crittenden of Howell arrived and ordered P. H. Swarthout, local undertaker, to take charge of the body. No inquest will probably be held.

Mr. Carrol has lived in this vicinity for the past 30 years but was born in Oklahoma. His father, Thomas Carrol, also lived here but died at the soldier's home, a number of years ago. He was married and has a son and two daughters. His wife obtained a divorce about 15 years ago. We understand he has a half brother in Detroit and two sisters in Oklahoma.

The funeral was held from the Swarthout funeral home Tuesday at 2:00 p. m. Rev. J. E. Berquist officiating. Burial was in the Pinckney cemetery.

Santiago, Calif.

W. C. Miller, Old Friend,
Just a few lines to you. We came down here night before last. Like it the best of any place we have been in California. It is 27 miles from the Mexican line. We were down to Tijuana which is just over the line.

We are having wonderful weather. It runs around 60 or 70 in the daytime & the nights are cool. Our camp is about 40 rods from the ocean. While at Los Angeles we went out in a boat deep sea fishing. Nothing biting only mackerel. We must have caught about 50 lbs. of them. Had a lot of fun. I called on Wirt Smith yesterday and Frank Backus. They are both fine. It sure seems funny to see the flowers here and to read about the cold weather back east. We don't know how long we will be here. We are going over into Arizona for awhile when we leave here. May cross over to Florida yet. We are staying at auto camps along the route. They run around \$7.00 a week, two beds, shower bath, hot and cold water, laundry room, reading room and toilet, gas stove and lights. It isn't so bad. Will close with best regards to old Pinckney.

FORECAST
The week of the 22nd in most parts of Michigan opens with moderating temperatures and cloudy weather. We do not expect any great amount of rain or snow during the early days of this week. While the low pressure area that we expect to cross the northern section of the United States may not be what is known as a "dry low," we do believe that precipitation will be rather sparse along its trail.

During Sunday and Monday the state may expect scattered showers or snow flurries. While there may be a reaction to higher barometer and clearing weather shortly after the week begins, there will again be cloudiness and more snow flurries.

About Tuesday or Wednesday temperatures will start a downward course which we believe will run rather low for the season and will last two or three days in most parts of the state.

We are fully confident that the thermal readings for Christmas eve and Christmas day will reach very low for the season, and in some sections will range from zero to 10 degrees below.

Cold weather will continue until after Christmas day, but at the end of the week there will be a change to warmer conditions.

The fair weather which we expect will cover the greater part of this state during the middle of the week will give way at the end to increasing cloudiness and rain or snow storms.

Cold Weather Produces Medicine

Cold weather produces another crop besides ice. Sodium sulphate is surrendered in large quantities when the water temperature is below freezing on Great Salt Lake, Utah. Here a \$25,000 plant works an average of two months a winter harvesting and refining Glauber's salt. Because the cold must be of a certain sort, there are some winters when no work can be done.





K. BROWN DIED SUDDENLY AT ANN ARBOR

Well on Road to Recovery Sudden Relapse Proves Fatal

Whole community was shocked today morning to learn that Dr. K. Brown, one of Nashville's best and respected citizens had suddenly passed away at an Ann Arbor hospital, death coming at 9:30 Tuesday night following a day in which doctor was felt to be well on the recovery.

Brown had gone to the University of Michigan hospital on Armistice day to undergo a course of treatment for a serious malady which, to the observer, was unnoticeable, which was evident to himself. A few weeks ago he underwent an operation and his recovery was so rapid that it was believed he would be within a few days. Mrs. Brown spent most of the past week at the hospital and on Tuesday afternoon she returned home reporting she felt so much improved and with the thought of returning so soon. He had shaved himself, well, laughed and talked throughout the day. However, a relapse was suffered Tuesday night resulting in his death at 9:30 o'clock.

Brown was born April 24, 1882, at Wm and Mahala Kice Brown in Nashville, Ind. Early in life he moved with his parents to Oklahoma, where he grew to manhood. Working his way through school he attended and graduated from the Norman, Okla., University, and the Illinois College of Medicine, graduating from the latter in 1914. In 1916 he came to Nashville and with the exception of 6 months spent in Lansing, had been continuously practicing his profession here since.

August 1, 1916, the doctor was united in marriage to Miss Bessie LeFebvre, of Chicago, and to this union two children were born, Carl, age 12, and Jean, age 9.

Surviving besides the widow and 2 children, are two brothers, Maurice, of Detroit, and one sister, Mary Brown of Cassing, Okla.

Dr. Brown was a member of Nashville lodge, No. 255, F. & A. M., and other Masonic bodies, and his lodge, No. 37, K. of P., in each of which he was a highly valued and beloved brother. He had also served his village in an official capacity, with a term as village councilman and as a member of the board of education, holding both the latter with the expiration of his term earlier this year.

Not affiliated with any church, yet Dr. Brown possessed religious convictions which proved the education he placed upon things spiritual. In a letter recently written to a friend in Howell, Mich., he expressed his belief in Christ as a personal faith and his effort at adhering to his belief. While not actively engaged in a profession of religious duties, he led a Christian life in his ministrations to the sick and afflicted with a gentleness and sympathy which were highly considered worthy.

Dr. Brown will be sorely missed by the community. Respected and loved for his expert professional services, he will be cherished in every household where his ministrations eased the affliction of illness and a cheerful word has encouraged others in the battle toward recovery. The family has the kindest sympathy of a host of friends who identify with them in their loss.

Funeral services were held Saturday afternoon at 2 o'clock at the lake view cemetery. Rev. A. L. Bingham, pastor of the Evangelical church officiating. Nashville News.

Red Cross Put Heavy Task

Red Cross calls for help in relief of victims of disaster. The organization is working to provide relief for those affected by recent calamities.

Red Cross Relief

The catastrophe causing the great loss of life and most widespread devastation was the West Indies hurricanes of September, 1928, in which more than 2,000 lives were lost in Florida, Porto Rico and the Virgin Islands. A relief fund of \$5,883,725 was contributed by the public, following a proclamation by the President of the United States, to which the Red Cross added \$50,000 from its own treasury, and the society was enabled to give relief to more than 700,000 persons.

Red Cross Relief

In the early Spring, river floods in the southern states cost a heavy toll. In 1928, 76,000 inhabitants were displaced in four states. Approximately 4,500 families, approximately 20,000 persons, with food, clothing, temporary housing, feed for stock and seed for replanting.

Red Cross Relief


In all, thirty-eight states were visited by calamities during the year, affecting 364 counties. Twenty-eight counties were devastated twice by disasters, and at one time had as many as 120 disaster relief workers, nurses and other representatives in the field. Funds for this relief work are obtained in the annual roll call for members, which occurs from Armistice Day to Thanksgiving Day, November 11 to 28. Only once a year—during a period of Roll Call—does the Red Cross ask public support to carry on many activities.

BUY 1st CHRISTMAS SEALS IN LIVINGSTON COUNTY
 Miss Laura Hoff, Pinckney, and W. B. Lamb, Howell, win the honor of being the first 1929 purchasers of Christmas seals in Livingston county, a report on early buyers of the seals in Michigan prepared by the Michigan Tuberculosis Association shows. Remittance for their allotments of the health stamps were received by the Association shortly after the opening of the sale.

Pointing out that present industrial and financial conditions necessitate increased emphasis upon public health endeavors, Dr. Guy L. Ketchum, Health Commissioner, in support of the Christmas seal campaign, tuberculosis may be combated a letup.

"Periods of economic strain are usually accompanied by a lowering in the level of health," he states. "Tuberculosis particularly is a disease that thrives in times of stress.

"While an early return to normal in business and industry is anticipated, we must guard against any possible ill effects that may result from present unfavorable conditions in the Christmas seal sale, opportunity is given to all citizens in the organized campaign against tuberculosis, as represented by the seal of the Michigan Tuberculosis Association and its affiliated societies to be heard that the campaign to sell seals will receive the proper support it merits."



