This Article Deals Mostly With Things Political

Aside from interest in a few congressional contests, the Sept. 15 primary spotlight is centering on 3 way races by Republican candidates for nominations of U.S. Senator and lieutenant governor. Democratic candidates for the offices are unopposed. The Senatorship nomination, which would contest the seat now held by Prentiss Brown, Democrat of St. Ignace, is being sought by three men from the Detroit-Wayne county metropolitan district. Listed alphabetically they are:

Elton Eaton, liberal newspaper editor at Plymouth, a suburban community near Detroit who espoused "anti-boss" legislation in the House at Lansing; Homer Ferguson, the Detroit judge who figured prominently in grand jury indictments and court convictions leading to the "Horse Rule" amendments proposed for Wayne county; and Gerald L. K. Smith, Detroit's Protestant "Father Charles Coughlin" who left the ministry to join the late "Kingfish" Huey Long in Louisiana.

LIEUTENANT GOVERNOR:

Nomination for lieutenant governor is sought by 2 candidates from western Mich. Montclam and Oceana counties, and one candidate from popular Wayne county (Detroit). Listed alphabetically, they are:

D. Hale Brake, Stanton (Montclam county) attorney and state senator who presides as president pro tem, an opponent to branch banking, and a colleague of Editor Eaton in "anti boss" legislation which was vetoed by the Governor.

Eugene B. Keys, Dearborn's wealthy dentist - doctor - attorney - engineer who zoomed to the 1940 nomination as a darkhorse against a well known field. He is reported to have the support of Edward Barnard, Republican leader of Wayne county.

Thos. Read, Shelby, (Oceana Co.) practicing attorney, oft times an independent, former lieutenant governor and attorney general with an upstate rural, dry backing.

WAR ECLIPSE:

CURRENT COMMENT

Time was when a chicken thief ranked about the lowest in the category of criminals. However, it seems to have changed. We read that Thomas Donay, the former German army officer, accused of treason in connection with the Hans Peter Kraus case, has been transferred to the Miller prison from the Wayne county jail. It seems the other prisoners in the jail refused to associate with him and even threatened him bodily harm so the sheriff decided it was safer to send him to the prison for safe keeping.

Soldier voting is no nearer of accomplishment now than it was several months ago. The reason seems to be the poll or head tax. Years ago when the country was new many states charged a poll tax to raise revenue. Persons who did not pay it could not vote. We believe the tax was about a dollar a year but it may have been more in some cases. Today about all states have abolished the tax except eight in the south. So far they have been able to block the soldier voting bill which provides for abolishing the poll tax, claiming the latter is an infringement of states rights. As there are very few congressmen in Washington just now, most of them being home tending to their campaigns, it is doubtful if the bill can be passed over the southern opposition.

How vitally the nation needs steel is illustrated by the fact that in about a week, all bodies of army trucks will be made of wood instead of steel. The steel saved by this change will go to make 75 millimeter shells. In addition all army cots will be made from wood from now on, diverting some 78,100 tons of steel to their purposes.

Frank McKay is still tops as a politician and a rebuff or 2 means little to him. Last week Judge Ferguson, candidate for United States senator, spoke at the Ionia Fair and in Grand Rapids. He took pains in his speeches to repudiate all political bosses which was construed as a slap at McKay by the press. He also let it be known that while in Grand Rapids he had turned down a luncheon invitation from McKay. Did this phase McKay, not at all. In a press interview he said he approved the judge's speech condemning bosses, that in sending the luncheon invitation he had done so at the request of the Kent Republican county committee. This reminds us of a story they use they used to tell on the late Dr. John Heffernan, well known veterinarian of Pinckney and Gregory some 25 years ago. The story was that he was called to a farm to do some work and saw several children there who were summer boarders. Later making a second trip, he noticed the children were absent and inquired about them. The farmer's wife said "Oh I found out they were Irish and sent them back, I wouldn't have them around. Whereupon Heffernan, who was full blooded Irish himself, making one of his most courtly bows, said "My Dear Mrs. Soandso, you did just right, if I had been in your place I would have done the same thing myself."

The death rate from alcoholism is rising according to the bureau of census at Washington, D. C. In 1940 there were 1.9 fatalities in every 100,000 people from alcoholism. The highest death rate from alcoholism was in 1907 when it rose to 7.3 percent per 100,000. The lowest was in 1920 when it fell to 1.0 percent per 100,000. The alcoholism death rate among whites is 1.8 compared to that among negroes which is 2.5. The rate for Indians is 6.5. The male death rate is six times that of the female. In 1940 twenty percent of deaths due to accident involved alcoholism; 15.5 led to influenza and pneumonia and 4.3 to suicide.

Dear Paul:

I am sending you my new address we get our mail at Los Angeles now. We are on tank maneuvers in the desert. We came last Tuesday night. It is sure hot, about 138 today and that is what it is most of the time. It is hotter inside tanks. They are like ovens. We take enough salt to keep the Morton Salt Co. in business and the water cans are always empty. We have good chow and all the fruit juice we can drink. The only living things I have seen here are lizards, ants, rattle snakes and one jack rabbit.

I am an assistant tank driver I think after I get used to the heat I will enjoy it. We don't do anything from 10:30 a.m. to 4:30 p.m. We have nothing to read and you can imagine how glad I felt when I got your paper tonight with all the news I sure enjoy every word of it. I like to read what the other fellows are doing and what camps they are in. They are sure scattered around. The truck leaves in about ten minutes to take us to get a shower bath so will close. I hope you continue to send the paper for it is one of the things I most enjoy.

XMAS MAILING FOR SERVICE MEN

The government is handing out advice regarding the sending of Xmas gifts to the boys in service via the mails. In the first place all Xmas gifts to the boys in service outside this country should be mailed by Oct. 1st and this includes those to be sent to Alaska. Each gift should be plainly marked Xmas parcel. The present limits for such a parcel is 11 pounds in weight and 18 by 42 in size. Persons are urged not to send food or clothing as the army and navy is provided with both. They are asked to restrict the size of the package to that of an ordinary shoe box and the weight to 5 pounds if possible. The parcels must be packed in substantial containers or boxes to resist pressure and covered with sufficient wrappings. Candies, toilet articles & soaps are suggested. They must be packed in wood, metal or corrugated paste board boxes. Sharp edged articles such as knives or razors must have their edges protected. No perishable material will be accepted. Intoxicants, matches, poisons or articles which may kill or injure or damage the mail are also barred. The address must be legible and include rank, name, army serial number, branch of service, A. P. O. number and postoffice. For the navy it should include the name of the ship, postoffice and naval unit. All postage must be prepaid.

last June. Township war boards will issue the checks to the people in their respective townships to cover the quantity of scrap made during this collection. Now this sum of money represents a considerable amount of salvage material. As a noted radio commentator would say, "This is no small potatoes, but we need more than somewhat." In fact another drive is being contemplated. When we consider that 440 some odd ships engaged in the business of transporting war materials have been sunk since Pearl Harbor, and very few of those sunk in areas where recovery is possible, we can see the need of collecting together salvage material to replenish the Merchant Marine. If the Merchant Marine was the only demand placed on salvage material it would take innumerable tons of salvage material to replace what has been lost.

Now in addition to the shipping losses other losses have been incurred. Implements of war are necessary to be created. All of these things require material which is scarce. I believe that it behooves every person to do all that they can possibly can in collecting salvage material and selling it so that our industries may not want for the vital material.

The Township War Boards have a plan as to how the next salvage drive may be conducted. From all outward appearances there will be scrap depots where people will take their salvage and be paid for it at the time that they unload. This will facilitate matters greatly. This last salvage was new to one and all and mistakes were made and time was wasted. However, we feel that in the future we may profit by the experience we had last summer.

The second salvage drive should be launched after the fall work is pretty well along and before winter sets in. This will give every person an opportunity to make a contribution. It looks as though our major job is food production, and the rest of these jobs will have to be fitted in during times when agricultural work is a little slack.

CONGRESSIONAL NEWS LETTER

United States Forces Fighting On Many Fronts

The United States has now been at war more than 8 months and already our armed forces are fighting in all parts of the world. The first fortnight of August saw our navy and marines take the offensive against the Japs in the Solomon Islands in the Southwestern Pacific with air support from United States forces based on Australia. The Navy bombed Jap held Kiska in the Aleutian Islands. American air forces in China have been aiding the Chinese by continued bombing of Jap bases in China. In Egypt our air forces have been helping hold Gen. Rommel in check by bombing Axis bases, convoys and communication lines. Our land and air forces in the British Isles are steadily being increased and American bomber and fighter planes have participated in raids on German held areas on the Continent of Europe. Our merchant ships under the convoy are carrying lease-lend goods to Russia and England.

U.S. Navy Takes The Offensive

The most significant action of the past two weeks from our point of view is the offensive against the Japs in the Solomon Islands area. It is important not only from the standpoint of safeguarding our supply lines to Australia and New Zealand and as providing if successful, bases for further offensive action against Japs in the South Pacific, but also because as Admiral King has said, "it marks our first assumption of the initiative and of offensive". The psychological value of the announcement that we were attacking the Japs and pushing them out of territory they have seized is considerable.

Critical War Material

According to an article in the Washington Times Herald of August 9, 1942, New Jersey civic leaders and construction leaders have been unable to obtain government approval for construction of a shipyard and school buildings. What they were endeavoring to learn is how a \$2,000,000 horse racing plant of steel, copper and other war material's could be erected after the war. A number of prominent building contractors, architects, attorneys, Board of Education members, clergymen and the shipyard promoters have been trying to discover how the Garden City Racing Assoc. was able to by-pass war restrictions. The group had twice carried its fight to the WPB and to Mr. Nelson, but the work continued underway at the race track until it was completed. In these days when critical material is so drastically needed in war production no allotments for unnecessary buildings should be made from critical materials.

Of Interest to Agriculture

1-The new crop forecast of the Dept of Agriculture reflecting conditions in July indicates crops 21 percent above the average of the 1922-1932 period and yields per acre are expected to be 5 percent larger than in any past year since 1920.

2-Of estimates on individual crops, corn is forecast at 2,754,000 bushels the largest since 1932: 955,172,000 bushels of wheat, the largest since 1916. Barley is estimated at 417,000,000 and rice at 74,000,000 these being 15 and 35 percent respectively larger than in any previous year. In addition the rye crop is expected to be the largest and the grain sorghum the second largest in 20 years or so.

Cost Of Living

The cost of living picture as of the end of June 1942 is given by the Bureau of Labor Statistics:

Food prices have contributed primarily to this rise, the food index having risen to 123.2 in June 1941 from 93.5 in August 1939. Clothing prices have advanced from 100.3 to 125.3 or 24.9 percent. Rents have advanced approximately 4 percent.

Weekly Wages in Manufacturing

According to a report of the National Industrial Conference Board the weekly average pay for workers in 25 major manufacturing industries was \$39.53, advance of 1.4 percent over the May figure, 15.4 percent above the figure for June 1931, and 38 percent higher than the 1929 average.

Steel Production Nears Record

The steel industry, according to the American Iron and Steel Institute has in first 7 months in 1942 turned out approximately 40,719,000 tons of steel.



- (2) After defrosting, wash the entire interior of refrigerator (coils, shelves, trays, etc.). Use lukewarm water and mild soap, followed by fresh water with a little baking soda. This banishes ice-box odor and leaves your refrigerator clean and fresh.
- (3) Wipe up fruit and vegetable juices as soon as they are spilled. (They harm the finish.) Wash the outside surface of your refrigerator with warm water and soap and dry with a soft cloth.
- (4) Don't overcrowd your refrigerator. Place left-over in small containers to save space. Always let food cool before placing in refrigerator.
- (5) Unless the motor of your refrigerator is hermetically sealed, have it oiled and inspected regularly.
- (6) Be sure there is adequate air circulation all around your refrigerator. Move it an inch or two out from the wall if necessary. The Detroit Edison Company.




