The country here is beautiful and the biggest crop is sugar. They also produce coconuts, bananas, grapefruit, oranges and every thing else in that line. They also sell a high grade of rum but I have not sampled any of it yet. The girls here are Spanish and on the dark brown side.

Things are high here. Cigarettes are 60c a package. But still it is not such a bad place. Nevertheless I will take the states for mine. Thanks for the paper. I appreciate it. So long for this time and here's hoping that I will be back to pitch for you next year-1944.

A Little Comment on Things Political in Michigan

Consider the political importance of Mich. farmers on issues of price parity and war time and on the public careers of Prentiss Brown, Murray Van Wagener and Harry Kelly. Prentiss Brown, a lawyer at St. Ignace who made good at Washington, lost the Michigan election by 28,000 votes. There were that many farmers that did not like him.

In opposing the racket-busting Hon. Ferguson of Detroit Brown had the political light of his life. He needed every vote to win. Yet he stuck to his convictions, opposed the American Farm Bureau Federation and the Milk Producers' association. Today, as the new administrator of the OPA, the small town lawyer from the upper peninsula has one of the most difficult and disagreeable tasks at the nation's capitol.

He will try to sell rationing of gas tires and food to the American people. This assumes correctly that at present it is not sold to the nation.

As some citizens see it, the vitriolic Leon Henderson made the mistake of trying to impose the same pattern of transportation rationing upon every square mile of land in the U.S., disregarding the fact that transportation needs vary.

The new OPA czar, as the newspapermen see it, has canny ability of getting along with folks.

Prentiss Brown may be expected to talk little, act deliberately, and try always to keep in touch with folks "back home".

He will return in Feb. to sound out opinion in such various problems and he has already indicated an intention of making the state an experimental "test tube" in the matter of rationing, particularly in the industrial war centers.

In rationing food Brown again finds himself dealing with farmers. That is a bit ironical, perhaps, for a man who staked his political future on a personal conviction of what was right.

Murray D. VanWagoner also risked his future on vetoing Michigan's time bill. He lost the election by 72,000 votes.

There are political observers who believe that this veto alone cost him the election.

NEW MAILING RESTRICTIONS

On account of the huge amount of mail sent overseas to men in the armed forces the postal dept. has issued new mailing restrictions.

No package can be sent to soldier unless it contains an article requested by the soldier and the request has been approved by the battalion commander.

The packages must not weigh over 5 lbs. be more than 15 inches in circumference.

Magazines and newspapers may be mailed only by the publisher and only if the soldier is a subscriber. Single copies by individuals may not be mailed overseas.

Letters to soldiers by families and personal friends will still be accepted for mailing.

NEW FEDERAL RULING

Under a new federal ruling oil stations can now only operate 72 hours per week. They must post in a prominent place the hours when they will be open. These hours cannot be charged until after 7 days.

CURRIER COMMENT

The agitation against Edward Flynn, nominated for ambassador to Australia is purely political and is formed by a bunch of politicians opposed to President Roosevelt but who have found that attacking him personally pays few dividends as it makes a martyr of the president and puts them in the role of persecutors. However they do not hesitate to attack any of his friends or assistants. Mr. Flynn has always been a friend of the president and the only Tammany man who has always supported him. According to Drew and Alsop commentators when the lease-lend bill was put up for passage it found hard sledding and prospects of its passage looked dark. Mr. Flynn then Democrat national chairman was sought for. He called the Democrat isolationists before him one by one and persuaded them to go down the line for the bill. Failure of this bill to pass might have meant a victory for Hitler. As the Lease-Lend bill is the only thing that kept England and Russia in the war.

All persons are requested by the federal government to carry their draft registration cards with them always as in this way they can avoid much inconvenience. The government expects soon to start a roundup of draft dodgers and if you are caught without one you are liable to be classed with them. There are said to be 1500 draft dodgers in Wayne county alone. These may not be dodgers but they have not kept the draft boards informed of their changes of addresses and so are classed as draft dodgers. In the last war draft raids were common. Draft halls, theaters and night clubs were the principal places raided and many dodgers were picked up although in those days they were called slackers. In a raid on the Pier dance hall a Pinckneyite was taken and held the night in jail. He was released when he proved he was not of draft age.

Reasoning that Wayne county may be made to accept half a loaf instead of a whole one, a bill has been introduced to increase Wayne county's representation in the legislature from 21 to 25 and that of Oakland county 2 to 5. An effort will be made to get this law on the April ballot in the form of an amendment. According to the constitution Wayne county is entitled to 39 representatives according to population. Still for many years the legislature has refused to give this county her legal rights.

We rather admire the course followed by Attorney Gen. Rushton. He pronounced the time change bill unconstitutional and stuck by his gun. He welcomed a contest in the supreme court over the bill and said so when in ten supreme court contests that he has won every one. He also added that the people in the middle west so far don't know they are in a war. They are interested in making a few extra dollars on their crops and get as much money out of the war as possible. Later in a committee hearing on their bill a member of the legislature remarked that farming was more important than the war effort which Mayor Jefferys of Detroit denied.

The Detroit Free press sums up the action of the Michigan House of Legislature in passing the time change bill 71 to 22 with one word, Cowardice. They claim privately that the legislators admitted that Attorney General's Rushton ruling that the bill was unconstitutional was right and that they were pledged to a change by their constituent and were in a hurry to fulfill their pledge and pass the responsibility for defeat of the bill to the senate or Gov. Kelly. However the senate is composed of cooler heads and there will be no pell mell rush as witnessed in the house. They have called a recess and sent a delegation to Baltimore where a hearing is being held on the change

THE RICKENBACKER SPEECH

We listened to the speech of Capt. Eddie Rickenbacker at the Book-Cadillac banquet last Friday night and were touched by the first portion of it depicting his escape from leath but disappointed by the last portion of it when he attempted to saddle labor with all the mistakes and shortcomings of the war. It was a typical labor baiting speech such as might have issued from the lips of Tom Sawyer or some other anti-laborite. Rickenbacker's listeners were almost entirely upper crusts and industrialists and his speech was right down the alley. Replying to the attack on labor Philip Murray, C.I.O. pres. Murray pointed out that labor's strike record since Pearl Harbor has been good, amounting to less than one tenth of one per cent of man hours worked.


I honor Capt. Rickenbacker for the things that he has said and done, but I deplore the things he has said about labor. They were harsh, unjustifiable on misinformation and misunderstanding. I ask the LORD to forgive him, for he knows not what he does he said.

CONSERVATION NOTES

hunting season is being advocated. The average snow dept. in northern Mich. is the greatest it has been in the last 8 years. Responding to a complaint of a super-abundance of skunks in and near Tawas City, Paul Harvey, a trapper proved a "Pied Piper" in 2 weeks when he trapped 257 skunks and 100 cats. The cats appear to be living in the same den with skunks. The Mich. Smelt industry is now a \$100,000 a year business. There were only 3,922 conservation law cases listed in 1942 compared to 5,365 in 1941. A 30 day deer hunting season and a 30 day upland bird hunting season and conferring on the dept. of conservation authority to handle the deer herd through antlerless deer.

Beaver trapping season is permitted in the upper peninsula from April 1-15 and in northern lower Michigan March 14-31. The first state land sale at Lansing in 1943 disposed of 265 lots and 3,830 acres of land for \$19,329. The sale of hunting licenses showed only slight decrease last year. 796,321 fishing licenses were sold a 4 percent decrease. 562,229 small game and 201,029 deer licenses, a 5 percent decrease. One barrel of oil in every seven used in Michigan comes from state owned wells or wells on state land. The CCC camp at Higgins Lake will soon be reopened as a rehabilitation camp for men from state prisons.

Again, here is an illustration of how a man's personal conviction may affect a political career. The political plight of Prentis Brown and Murray D. VarWagoner brings a parallel case in 1943. What will the Republican legislature do to the time bill? And if the legislators enact a straight return to Eastern standard time for the entire state what will Gov. Kelly do about it?

A few days ago, when this column was being written, the house had approved a bill which provided for two time zones: War Time for the Detroit metropolitan area and standard time for the upstate rural area. In the first place, Gov. Kelly owes his election to upstate counties. Van Wagoner carried Wayne county, the Detroit area. The Democratic majority in Wayne county was reduced considerably by the popular Kelly of Detroit and the evident favor which his running mate, Dr. Eugene Keyes, enjoys among the voters.

Second, Gov. Kelly is endeavoring to represent the people of Michigan not the farmer, worker, merchant but the collective people. A third observation: Regardless what the legislature does, regardless of what the Gov. does, the people must expect to contend with TIME INCONVENIENCE as one of the sacrifices expected in a war.

If the time is not changed, then the vast farming and others who do not approve of the present time, will continue to be inconvenienced. Farm production may be handicapped by loss of labor daily on thousands of farms.

If TWO time zones are established one for the eastern belt of Mich. and one for upstate and rural counties, the citizens of each area will be inconvenienced when they go outside their area.

From a war production area eastern war time for the industrial war workers and eastern standard time for the farm workers would result in the greatest efficiency in output of munitions and food, respectively.

But regardless of what is done, you cannot escape the annoyance of inconvenience. No matter what's done everyone must expect sacrifice. It is part of the price of winning the war.
