### SOLDIER LETTER

North Africa, Feb. 3, 1943

I have been wanting to write to you for a long time and now have an opportunity. Your paper has caught up to me and I sure look forward to getting it. Everything is quiet here at the present. Since the landing here we have been more or less continuing our training here for future action. We had little difficulty in getting a foothold here and are well prepared for whatever may come.

Best life is not so bad so far but expect plenty of hot weather later. Read in the paper that Harold Jansen of Milford came over on the same boat but have not met him as yet. Don't get to see many of the people here except Arabs and they are a dirty bunch. Charge your four prices for everything and steal any thing they can get hold of.

The boys in the South Pacific are catching plenty of "hell". Hope Howard Read and Julius Aschenbrenner have a speedy recovery from their wounds. At the present I think they have a harder job than we have here. The local honor roll is increasing fast and the boys are scattered all over the world. Was surprised at Douglas Plummer going. Thought him him too young but guess he will make out all right. Sorry I can't tell you more but you know how it is. Hope to be back soon and then will give you the lowdown. Will write again later. Say hello to all the home folks for me.

## Mich. Mirror State News

### In Which the Liquor Control System Is Discussed

What's wrong with the Michigan liquor control system?

The answer is not new and it's at least 75 years old- perhaps 7,500 years old.

And here it is: Lack of law enforcement backed by public opinion. But before you grab your telephone and start calling for your local legislator at Lansing to do something about it no doubt, getting the legislature to enact another law for officers not to enforce- better adjust your specks and look at your own front yard.

The solution is so simple. it's difficult to make the public believe that it is true.

If the taverns are flouting the law and some of the dance halls and nighteries are cesspools of vice, initial responsibility for those local conditions rests with your local township board or county sheriff (if the tavern is outside the town) or with the city council and local chief of police (if it is inside town).

The State of Michigan has a responsibility of course. It is an important one.

But the first responsibility has been placed by the legislature in its liquor control act upon the home government.

Do you know that the Michigan Liquor Control commission must revoke the license of by-the-glass establishment if any local government unit- township, village or city board makes a request for such action.

Do you know that all license by the glass places must first be approved by the township, village or city before the state will issue a license.

Local governments may prohibit the sale of all alcoholic beverages on Sundays.

Dance hall permits must have the approval of the chief of police or the sheriff.

85 percent of all license fees are returned to local communities showing the law intended them to police local conditions.

The state is not immune from criticism but should only step in when local governments fall down on the job.

The liquor commission has completed a survey of two-thirds of the state. They find conditions bad outside incorporate villages and cities where despite the fact the township boards get 85 percent of the license money little is spent for law enforcement.

Under present laws any community can have exactly the sort of conditions it wants.

This is the democracy of grass roots. Is it a desirable policy?

### NEIGHBORING NOTES

Jack Kelly, veteran showman of Michigan died at St. Lawrence hospital, Lansing Friday. He was in the show business 47 years. The show was formerly known as the Kelly & Brennan Shows and several shows were operated at a time. Kelly's daughter managed the show last year.

Federal Judge Picard signed a temporary injunction restraining 10 slaughterers from further beef and pork killing. March 15 is set for a hearing on why the injunction should not be made permanent. Among those listed are Zeigler & Steeb of Dexter who killed 159 beef and 102 hogs over quota and Oberly & Lozo of Fowlerville who were 28 head of cattle over quota.

Armour & Co. have closed their branch at Jackson due to scarcity of meat and labor.

The new Federated church at Brighton burned down last Tuesday. A. J. Stroud, supt. of Stockbridge schools since 1935 has resigned.

Stockbridge will collect tin cans the week of March 15.

John Rane of Whitmore Lake has been appointed to the Washtenaw county draft board to succeed Dr. Faye Palmer of Chelsea resigne.

The Vagabond Coach Co. at Brighton has a contract to build 200 house trailers for the National Housing Agency.

Fowlerville has decided to continue on slow time being about the only place in the county to stick to it. She has no war industries.

## CURRENT COMMENT

### By Yo. Editor

With but two dissenting votes the school aid bill giving the schools \$5,000,000 more funds for the ensuing year passed the senate last week. and according to indications will also pass the house. The bill is not satisfactory to the counties with the biggest population as the funds are distributed according to valuations and these counties with high property valuations do not get as much as rural counties. Under it Washtenaw county will receive less than she is now getting but Livingston will get much more.

The meat shortage is becoming so acute that a market selling horse meat only has been opened on Gratiot ave. in Detroit. Its proprietor is Max Fineman and he admits that his market is an experiment. However he has opened it in a district populated by French and other people who have eaten horse meat for years. It's only selling for about half what beef costs. This horse meat comes from young wild horses brought from the western plains. If the beef shortage continues we may all have to learn to eat horse meat and like it.

### According to Gov. Kelly the time

question is dead for the duration of the war at least and there will be no more tinkering with it by the legislature. The gov. added that there is no responsible leadership in the house urging that Detroit and other cities be forced to go on slow time nor does any leadership in Michigan that the rural districts be forced to use fast time. Legally the state is on slow time, the state supreme court got around this by shifting their hours.

Every time there is a particularly brutal murder in this state there is agitation for a capital punishment law in the state. The last such bill was seriously considered back in Gov. Murphy's time but as we remember it was vetoed. Since then no serious consideration has been given to such a bill. Following the brutal murder of Clara Johnson in Ionia another capital punishment bill has been introduced in the house at Lansing. We would be for such a bill 100 percent if we could be shown that it tends to reduce murder. However New York & Illinois have had it for years without any reduction in their murder rate.

### There has been much outcry

inst centralization of gov in the hands of the few in Washington and depriving the people of their vested powers. Yet in some ways the present state legislature would outdo them in this respect. Great efforts have been expended to abolish the elective office of state highway commissioner and make that office appointive. Now state administration leaders under the guise of a short ballot would also abolish the election of attorney general, sec. of state, treasurer and supt. of public ins. and make them appointive by the Gov. Al so that of auditor general who would be appointed for 5 years.

### Most Rev. Joseph Albers, Bishop

of Lansing has stated that through faculties vested in him by Pope Pius XII because of food shortages and intensification of the war effort special dispensation from the church saw of abstinence during Lent has been granted except for Ash Wed. March 10 and Good Friday. Abstinence will be obligatory only on all Fridays in the penitential season.

An effort is being made under the camouflage of aiding the food shortage to reinstate the old method of campaigns by free distribution of seeds. This was a wonderful thing for the congressman as the government paid all the cost. It was a pip of an idea while it lasted although many a vote was lost when a voter failed to receive his annual package of seeds. It was finally ridiculed out of existence. Probably not only half of the seed was ever planted as doctors, lawyers and practically every one was on the congressional list for free seed handout.


The subject of this sketch is Rob-

Registration of Absentee by Oath Upon receipt of such affidavit in the time specified herein the clerk shall write in the registration book the name of the applicant together with the other information required by this chapter and such applicant shall thereupon be deemed to be duly and properly registered.

Note-If his acknowledgment is taken outside of the state, the Certificate of the court law the person taking the acknowledgment is a notary must be attached.

If any person whose name is not registered shall offer and claim the right to vote at any election or primary election and shall under oath state that he is a resident of such precinct and has resided in the township, village or city, 30 days next preceding such election, designating particularly the place of his residence and that he possesses the other qualifications of an elector under the constitution and that owing to the sickness or bodily infirmity of himself or some member of his family, or owing to his absence from the township, village or city on public business or his own business, and without intent to avoid or delay his registration, he was unable to make application for registration on the last 3 days provided by law for the registering of electors preceding such election or primary election, then the name of such person will be registered, and he shall then be permitted to vote at such election or primary election. If such applicant shall in said matter, willfully make any false statements he shall be deemed guilty of perjury. Provided, That any city may provide by its charter or resolution approved by a majority of the members of its legislative body for the registration
