We use French money with its franks and centimes. The paper it is made of is not much good. There is lots of wine here I hope all my friends in the army are coming fine. I have a lot to tell you when I get back. I have received my campaign ribbon for valor in the African war. I will write you more about it later.

How is Joe, Bill Jeffreys, Anna Reason and Shirley and all my nice girl and boy friends there. Say Hello to old Pinckney High School and all the boys and girls there for me. I would like to see some pictures of you people. How are Mr. and Mrs. W.H. Meyer? I will write soon again. Also how is Friday Haines.

The food is fine. I had a China hen for dinner Sunday and it was great. God Bless you all. Pvt. Sam Lafata

### SAILOR LETTER

New Orleans, La. July 1, 1943

Dear Folks: I have just returned from a 21 day cruise in which I was 500 miles out into the Atlantic. I was in New York City and saw the Statue of Liberty. I am learning to be a deck anti aircraft gunner. I hurt my arm a little but it is all right now. Saw waves 50 ft. or more high and they came right over the deck. You have to watch your step or you will get swept off boat by them. Saw a German submarine one night but we lost it in the fog. Picked up 10 survivors of an American merchant ship that was sunk by the same sub. It is supposed, and took them to a hospital in Virginia. I was homesick as the deuce at sea but am getting over it pretty well now. You probably won't hear from me for awhile again as we are going out to sea again very soon and it will be some time before we get back again. Yours,

## County Salvage Collections

This County Leads in Waste Fat Collections, Waste Paper is Now Desired

During the month of June the quota for Livingston County was 230 pounds; the amount collected was 2336 pounds, putting the county at the top of the list of Michigan counties in percentage of quota collected, a dispatch from John T. McGillich, Executive Sec. for Mich. General Salvage Branch, and Kenneth M. Burns, Chairman, to W. E. Robb, Chairman of the Livingston County Defense Council, states: "Only five other counties exceeded 100 per cent of their quota."

However the quota set does not appear to be at all difficult and we can do better. This good showing is a tribute to the women of the county who have patriotically and continuously saved their kitchen fats and saw to it that they reached their butcher shop. When a campaign is first launched it is easy to work up enthusiasm but it is the long pull that counts. Remember - "Fats make gunpower, and gunpower fights our war." This is defense work. Don't get down now - there's a long pull ahead yet.

### WASTE PAPER AGAIN NEEDED

For five weeks now, Michigan paper mills have used more waste paper than they have received. There is a need for additional newspaper, magazine, brown paper and corrugated cardboard. However do not save it unless your salvage dealers are buying waste paper so first inquire if there is a market, then you can again help the war effort by again saving paper. One Livingston County Dealer quotes 30c per hundred for magazines, etc. and the same price for newspapers except that if newspapers are loose and not tied they pay only 10c per hundred lb. If a number of families would give their waste paper to some patriotic boy who would collect, tie them and take them down to the junkyard he could thus make some spending money.

Garth Meyer saw some of these birds pounce on a lamb and drove them away but the lamb they seized was dead when they got to it. The conservation officer was called in and he gave them permission to shoot or trap them but so far none have been caught.

## Old Age Assistance

Social Aid Figures and Increases Are Given for the Past Year

Payments to Old Age Assistance recipients in Livingston County increased steadily during the last year and reached an all time high this month according to Miss Hazel M. Phillips, Supervisor of the County Bureau of Social Aid. 528 Old Age Assistance recipients in the county received a total of \$13,640.60 in July for an average payment of \$26.00. This is a notable increase over the average grant of \$17.00 a year ago. It is interesting to note that during the same period the number of persons receiving Old Age assistance decreased from 530 in July 1942, to 528 this month.

Payments to Aid to Dependent Children recipients have increased even more than those to Old Age Assistance persons. The average payments were \$52.40 compared to \$37.00 a year ago.

Payments to Aid to the Blind recipients which number only 4 in Livingston County increased from an average of 21.13 in July 1942 to \$26.00 this month. Each of the Aid to the Blind recipients living in a household where the other members are receiving either Old Age assistance or Aid to Dependent children.

The allowances for food, clothing and fuel were increased to provide for higher living costs. Increased payments to Old Age Assistance and Aid to the Blind recipients were made possible by the transfer of funds from the administrative, burial, and direct relief accounts to the Old Age assistance and Aid to the Blind accounts and the matching of federal funds.

## Mich. Mirror State News

Michigan's Part in the World War Is Reviewed

Michigan's contribution of manpower to World War II is already more than double the entire record for the first conflict, 25 years ago.

Approximately 350,000 men and women have left Michigan homes in cities and on farms to serve in Uncle Sam's forces all over the globe. That is a bit more than a third of a million people quite a legion.

World War I records list the following: Army 152,598; Navy 19,413; Marines 3,318 total: 175,329. Of the latter number 4,295 became gold stars on the state's service flag... 2.4 per cent of all and not all those were killed in action, as influenza and other diseases took a heavy toll of lives.

In other ways the contrast is sharp. Our part in today's war has already exceeded the entire time of our participation in the first conflict. France Italy and German as our Instead of fighting one war with Allies, we have two wars on our hands; our troops have yet to land on the continent of Europe (when this column was written)

We still have a long ways to go before our boys march to Berlin and Tokio.

There still appears to be a long long trail ahead. But victory is certain of that we are sure.

And yet, surprisingly and happily enough the Michigan mortality rate of our modern world wide engagements is apt to be considerable less than 2.4 per cent. Air planes and tanks are the front lines of days fighting. They require a comparative small number of men to operate them. It is a mechanized war, not a war of mass movements and entrenched lines.

Word from Africa is encouraging with respect to the price paid for Allied victory. Tunisia was taken with an unexpected small loss of men and material.

While American war workers may worry about our complacency, it is a fact that the casualty lists have been small to date. As for the boys who have been wounded there's something else to crow about. Approximately 98 per cent of all American wounded men have recovered to date leaving a mortality rate of only 2 percent!

Our boys are disgustingly healthy too. They receive only the best of food and medical care.

Every doughboy and sailor acquires a fatalistic attitude about his chances of coming back. Since only 2 per cent of the wounded die and since today's mechanized war has reduced the number of fatalities to date as compared with the last war military service becomes a great adventure to the average young man.

In the last war the state war board bought tractors, seed corn and seed wheat and retailed them at cost to farmers. The voters approved a bill that created a war board which Col. Roy Vanderhook now with the Michigan railroads assoc. was secretary. Gov. E.E. Sleeper was chairman.

With regard to war costs, the contrast is sharp indeed. Modern war machines are costly.

The entire country - and this goes for Michigan, too... is enjoying a prosperity jag.

The war is going to cost us many many times the dollars we paid in 1917-18.

But if the price of human life is less and our Michigan boys and girls come marching home, we will take our medicine and like it.

## CURRENT COMMENT

The big news of the week despite the Allied successes in Sicily, Russia and around Australia was the bombing of Rome by Allied planes. Rome is called the Holy City and is probably filled with more masterpieces of art and antiquity than any other city in the world. It is also the seat of the Vatican or the home of the Pope. However Mussolini seems to have taken advantage of the veneration in which it was held to use it for a base and factory site for war munitions. When the Allies attacked Sicily, the chief Axis support in form of food and munitions came from Rome and in order to win this base had to be put out of business. The Vatican was not damaged but some churches in the war district were. Such are the fortunes of war, which is no respecter of places or persons and has no rules. The war motto is "Anything to win." Judging from press comments the Allies have not suffered any loss of prestige by the bombing of Rome.

Last year the state highway dept. let a contract for the resurfacing of Grand River highway between Brighton and Howell which is one of the most travelled highways in the state and has become in bad condition, rough and full of holes. Then Charles Zeigler (Republican) was elected state highway commissioner and he promptly cancelled all contracts signed by his Democrat predecessor including the Grand River repair job. Protests to Zeigler brought the reply he would investigate the need of the resurfacing and if necessary he would let the contract. However the summer is rapidly passing away and with it the time for resurfacing and the road is getting rougher and rougher. This caused the Brighton Argus to lambast Mr. Zeigler for his lack of initiative and the Livingston County Press has echoed their sentiments by reprinting the Brighton editorial. Now the next move is up to Mr. Zeigler.

We note that Rep. Wm. Stenson of Greenland, Mich. who lost his seat due to the reapportionment law passed by the last legislature will appeal the law to the supreme court claiming it is unconstitutional. He claims that the counties who will lose seats in the legislature have agreed to help him finance the supreme court appeal. As Livingston County is slated to lose her legislative seat we suppose he included her in his appeal for funds. Under the law Wayne county gains 6 legislative seats and Macomb, Oakland and Washtenaw counties each one. The northern counties and the rural districts have no large cities on the other hand & would lose. An attempt to void the law by circulating petitions against it seems to have failed. 61,339 signatures would have to be obtained to such a petition.

Gov. Kelly says he is considering investigating reports that there is gambling in Macomb county. This Macomb county gambling dead cat has arisen to annoy every governor since the civil war or nearly that far back. The only gov. to effectively solve the problem was former Gov. Frank Murphy. He told the gamblers to close up and they did. Governor Fitzgerald left it to local officials which was the same as giving them the green light to go ahead. Macomb county officers have never been able to find any gambling joints in that county. The hubbub over Macomb gambling is said to be one of the causes of Fitzgerald's death. Gov. Murphy kept the gambling joints closed and so did Gov. Dickinson. When Gov. Kelly took office there were rumors which fanned into a flame when it became known that Mert Wertheimer and a bunch of Detroit gamblers had purchased the Jefferson Beach resort. Their claims that they intended to feature a merry-go-round and ferris wheel carried little conviction and when they opened full blast with a full equipment of slot machines and other gambling devices, they got front page notices. So did Gov. Kelly. His protests that he had no desire to be a reformer got him nowhere. But a petition asking the removal of Sheriff Theut of Macomb county for permitting gambling forced him to act. The gamblers are now said to

be under cover but undoubtedly they will soon attempt to profit by the investment when the publicity blows over or quiets down a bit.

**CONSERVATION NOTES**

There is a bumper crop of blueberries in the north woods. Anyone may pick them. Owing to the shortage of pickers, this dept. is allowing the use of mechanical pickers this year.

Archers will have 16 additional days to hunt deer in Allegan county this year. Leelanau county closed to deer hunters since 1935 will be reopened this year.

43,540 acres of state owned land will be offered for sale Aug. 5-6 for \$1000 per acre.

The muskrat, raccoon, mink and skunk trapping season is unchanged this year.

Bear hunting banned in Keweenaw and part of Houghton county since 1938 will be reopened this fall.

Michigan hunters will find an additional 293,839 acres of land open to public hunting this fall. The land was purchased with hunting license money.

In order to help those who go north after blueberries the dept. has issued the following bulletin on the berry districts. The following districts report bumper berry crops: North Baldwin on M-63, Traverse City, Roscommon, Mio and Lake Superior district in upper peninsula. In all other districts the crops are spotty or poor.

Permits to shoot on sight 5 deer which have been destroying crops in Clinton county have been given there. These deer are supposed to have come from the Livingston County herd.

\$625 was paid to trappers of predatory animals in June 45 pelts being turned in compared to 32 for June 1942.

As a result of a number of experiments conducted at Zukey lake by this dept. it is found that motor boats do not damage bluegill eggs and spawn. It was determined that bluegills fry are not moved as much as two inches from the nests.


