

## Michigan Mirror State News

State News Gathered from All Over the State of Michigan

This may be news to some folk. There's going to be an election in Michigan November 7.

With Generals Ike Eisenhower, Blood & Guts Patton, Omar Bradley and a million or so Yanks on the victorious march in France, Belgium and Germany newspaper headlines have been dominated by happy war news. Approach of V Day in Europe has put domestic affairs into total eclipse. When do we celebrate?

World history is rushing past with breath-taking speed.

Even a prospect of 16 years' residence by one president at the White House something we would not consider serious in normal times scarcely evokes more than a mild discussion from the man on the street.

It's the war, war, war, and a fervent hope for a quick victory that were thinking about this September, 1944.

When you go to the polls November 7, you will receive a presidential ballot and a general election ballot for state and local candidates.

This change in voting was authorized by the Michigan state legislature at the suggestion of the Republican legislative leaders who suspected that too many people were in the habit of riding presidential landslides.

To put the state ticket on its "own feet" free from any influence of a national political trend, legislators provided for a separate ballot that listed nominees for President and for Vice-President.

Now the Republicans are beginning to wonder.

In the first place, will the average voter remember to mark both tickets, instead of one?

The Democrat column on the state ticket will carry as its party insignia the picture of President Roosevelt.

Nervous Republicans wonder if Joe Doaks will mark an "X" along side of Roosevelt's picture thinking that they are voting for Mr. Roosevelt.

If enough people do this then any advantage enjoyed by Governor Kelly as the incumbent at Lansing might be nullified as goes the reasoning. Its a hard hard to stress your worrying, but such is the honest case of one Republican nominee on the federal ballot.

Secondly there is the much-discussed Detroit News Opinion poll, known as Detroit Speaks.

Conducted along the established methods of the Gallup polls whereby a cross section of population is used by trained interviewers to determine mass trends the Detroit study has revealed a 64.54 percent preference for Roosevelt and a 67.6 percent preference for Governor Kelly among metropolitan Detroit citizens who have an opinion.

### RENEWAL OF A GASOLINE BOOKS

Applicants for the new A books in the Pinckney area, may obtain their new books at the Pinckney High School Gymnasium on Sept. 19 and Sept. 20 from 1-00 P. M. to 9 P. M.

Applicants must present their old A book cover at that time and should also turn in their Tire Inspection record. If a person has lost his A book cover, he must wait until after October 1, and then apply at his local rationing board.

Application will be accepted by the rural schools acting as issuance sites on Wednesday, September 20th and new A books will be mailed the following day. One person may act as agent for many car owners to secure new A books. This in many cases will save driving.

## CURRENT COMMENT

By the Editor

As to the Jewish problem and L. K. Smith is so anxious to solve, W. A. Roney, Detroit News commentator, says there is no Jewish problem. He adds that if Smith is so anxious to solve the problem why does he not go to New York where 40 percent of the Jews in this country live. Michigan only has 1.57 percent. Mr. Roney concludes Smith thinks there are more Jews in Michigan. The Anti-Jewish persecutions began way back in the dark ages when some monarchs in need of money for wars etc, preferred charges against the Jews, imprisoned them and took away their wealth which they had accumulated by frugality and simple living and shrewdness. The main charge against the Jews has always been that they crucified Christ. This is not borne out by facts. Christ was tried by a Roman judge who pronounced the death penalty and the execution was carried out by Roman soldiers. It is true that the Jewish church preferred the charges against him and asked his execution but they composed but a small part of the Jewish nation. There were no papers or radios then and it is doubtful if the majority of the Jews even knew of his execution. Nevertheless the Jewish issue finds ready believers to this day and both Hitler and Mussolini climbed to power by their persecutions of the Jews whom they massacred by the thousands.

The Republican governors who have been broadcasting for Gov. Dewey are being referred to as the seven Charne McCartnys. The cause for this is that the Republican national committee released their speeches to the press before they were made and these failed to correspond to the ones they actually delivered. Both speeches to have been delivered by Governors Warren of California and Saltonstall of Massachusetts contained scathing attacks on Sidney Hillman and the C.I.O. As both Warren and Saltonstall of Mass enjoyed considerable C.I.O. support in the past they deleted this part of or condensed it into a few lines. It now appears the C.I.O. gave \$6000 to Gov. Dewey's campaign fund the last time he ran for states attorney.

The Detroit Free Press has refused to back down on its editorial scathing the Duke and Duchess of Windsor because the Duchess had ten hospital rooms and 6 nurses for an appendicitis operation. The Free Press says this was an Associated Press report and although the Duke and the doctor have denied the report the Associated Press has not. The Duke and Duchess were hailed as the lovers of the ages when he gave up his throne and she ditched her husband so they could get married. They went to Europe but on account of his pro-Nazi friendships the British government did not consider it safe to have him there and took him out of circulation by making him governor of the tiny, sandy Bahama Islands. Still the frequent visits of this royal couple to the states make good copy as they invariably pull something foolish.

For a long time we have wanted to write something on origin of family names. Back in Biblical times persons only had one name such as John Peter, Seth, Mark, Mary, Sarah etc. In wild uncivilized countries the same holds true today. This worked all right until the increase in population rendered it hard to distinguish a person by one name. In many cases they took the names of their occupations. John, the miller, became John Miller. John, the carpenter, John Carpenter and John the blacksmith, John Smith. This accounts for the numerous Smiths as there were numerous smiths or tradesmen. Take the name Palmer. The dictionary says a palmer was a person who visited the Holy Land, back in the middle ages and was privileged to wear sprig of palm leaf in his hat to denote the fact. The origin of names is further complicated by the fact that many names have come to us from the German, French, Italian, Irish, Welsh, Greek and other countries but undoubtedly every name was derived from some occupation, locality or event as perusal of the dictionaries of these countries would prove.





THE MICHIGAN MIRROR

Roosevelts popularity in Detroit is not surprising in view of the cities recent record of Democratic election majorities. In terms of votes we pointed out last week the Detroit swing would require an upstate majority for Dewey of around 250,000 to put Michigan safely in the Dewey column.

Kellys popularity in Detroit is subject to interpretation on many angles. It is because more people today know Kelly than they do Edward Fry, nominee of the Democrats? Perhaps they would prefer Fry if they knew more about him. Such is the campaign speculation and time is a big factor.

Certainly the high command of Michigan republicans do not consider that Michigan is in the bag politically. Starting Sept. 19 Governor Kelly and one or two other party candidates are going to make a 1,300 mile swing of northern Michigan going as far west as Ironwood. Nominee Edward Fry and other Democrats are rolling up their sleeves too for a vigorous campaign hopeful that the voters will lend an ear long enough for presentation of the candidates messages.

A third ballot for Nov. 7 will contain four proposed amendments to the state constitution.

Three were sponsored by the state legislature as follows:  
No. 1 Permitting a municipality to supply and to sell water to houses outside the city limits.

No. 2 Permitting state legislators to run for state office and continue as members of the legislature. The present law requires a resignation when a legislator becomes a candidate for state office.

No. 3 Increasing the compensation of state legislators from \$3 to \$5 per day.

No. 4 Permitting a municipality to give home rule to Wayne county.

Running an election and running a war is double responsibility imposed on American democracy this fall. If public opinion polls of recent years are any index domestic issues still are of more interest to American voters than international affairs. Despite our newest venture into the world politics were concerned primarily with the things which are immediately about us which concern our daily living. Self-interest remains the key too much of our thinking.

That boy who is overseas, our gasoline rationing, shortage of sugar for canning, overtime wages and food prices these are part of our war time thinking.

How much will the war influence our judgement on November 7?

A lot of Michigan candidates would like to know the answer.


