News and Items Concerning Our Boys Who Are Serving in the Armed

A telegram was received here Friday by Mr. and Mrs. Julius Aschenbrenner sr. informing them that their son, Stephen, had been wounded in action in Brenner Pass between Germany and Italy. An older brother, Julius jr. was wounded in New Guinea and received the Silver Star and Purple Heart another brother, George is in the USN in the South Pacific and a sister, Margaret is with the WAC's in Italy.

Pfc. Grant Carr is home from Laredo, Texas on 15 day furlough.

A letter received from Sgt. Gerald Swarthout by his parents, Mr. and Mrs. L. J. Swarthout says he expects to be home on furlough this summer. He is an air bomber gunner.

A letter received from Sgt. Lloyd Hendee written in Germany May 10 predicted a quick end of the war. He said the German offensive was only half hearted.

Mr. and Mrs. D. Hammer held open house at their home Saturday night in honor of their son, Gene, who leaves this week for Ft. Meade, Maryland for overseas duty.

A letter from Pfc. Joe Lavey stated he expected to be transferred from the hospital at Hamilton Field, California to a hospital at Clinton, Iowa. He had his jaw broken while fighting the Japs in the Philippines.

A card from the war dept. received by Mr. and Mrs. Earl Baughn informed them that their son, Cpl. Lawrence Baughn was on his way back to the states. He was wounded in the foot in Germany.

Pfc. Merlin Amburgey, recently discharged from the army after being wounded in France on D-Day has resumed his old job at the Hudson Motor Co., Detroit.

Capt. Tom Young of Gregory is now at Fort Sam Houston, Texas.

Capt. Paul Strawhecker, brother Mrs. Ona Campbell, has just returned from his 10th convoy trip across the Atlantic.

Sergt. Clifford Densmore, son of Mr. and Mrs. Charles Densmore of Patterson Lake and Detroit, has returned home from Germany after 38 months overseas, during which time he was in Iceland, England, France and Germany. He was twice wounded.

Sergt. Bill (Red) Dillon, son of Mr. and Mrs. Patrick Dillon of Howell, former Pinckney residents, has been given an honorable discharge from the army. He was overseas 80 months, was wounded in North Africa and again in France. His brother, John, was accidentally killed in Arizona while in the service and another brother, Patrick, is in the South Pacific.

Pfc. Glenn Kingsley, recently released from the Stalag IV prison camp in Germany arrived here Thursday from Fort Sheridan. He is at the home of his sister, Mrs. Andrew Campbell where his wife Thelma, and daughter, Glenda, have been staying.

Sergt. Dick Amo who recently returned from Alaska after 2 years there has many interesting stories to tell of that place which he thinks has a great future. Big salmon abound in Alaskan waters and the G. I. boys catch them for sport and throw them away. Trout are their favorite fish and there are lots of them there too. He was not in combat but has seen plenty of dead Japs and the caves where they lived which were large and consisted of several rooms. The Eskimos appear stupid and have very little education. He knew an eight year old girl though who could play the piano very well. She was part Eskimo, part Jap and part French.

He will go to Miami, Florida for a rest period.

Pvt. Jimmy Burns of the U. S. Marines was wounded in the thigh at Okinawa and taken to the hospital where Eli Aron jr. is attendant. He also has a tropical affection in his eye. He is the son of Mr. and Mrs. Ray Burns of Pinckney and graduated from Clarkston high school in 1944.

Garth Meyer, son of Mr. and Mrs. W. H. Meyer went to Detroit last Thursday and passed the physical examination for the U. S. navy. He is a senior and does not expect to be called until June. His brother, Edsel, has been in the navy in the South Pacific for 4 years and a brother, William, is with the parachute troops in Germany.

Ronald Darrow and Hollis Amburgey who were inducted into the U. S. Navy last week. Ronald is at Great Lakes, Ill and Hollis is at Newport, Rhode Island. The latter is a senior in the Pinckney school and Ronald a sophomore.

The armed forces will get most of the summer boys this summer. Among those who will be 18 and expect to enlist are Don Griffith, Robert Carr, Jack Holmes, Ross Lamb and Gilbert Bailey.

Experience in a Prison Camp

Pfc. Glenn Kingsley of Pinckney had Numerous Experiences During His Nine Months in a German Prison

Pfc. Glenn Kingsley who recently arrived here on 60 day furlough after 9 months in German prison camps, had many interesting and gruesome experiences. He was with the 79th division and was in England for some time before the French invasion. They were sent to take and hold an advance position near Brest, France. They held it for five days against severe counter attacks by German tanks and artillery. The American tanks and reinforcements never arrived. They surrendered July 4, 1944, after 80 percent of their men were killed. The 50 survivors were forced to march 200 miles to Paris. It took 30 days to make the march. Their rations were a loaf of bread and tin of fish for one week. Some fainted from exhaustion on the march and were kicked and beaten by guards. At Paris they were loaded in box cars. The doors were kept shut and a number passed out enroute to Germany. They were in a number of camps and had to work in the potato and beet fields and bury the dead. These were mostly Russian, Polish and Jewish civilians who were worked to death and starved. They died by the thousands and were buried in unmarked trenches. The food of the American prisoners was very scanty, mostly bread, potatoes with horse meat once a week. The G. I. boys who worked in the fields fared better as they used to steal potatoes, beets etc. The American air raids made a shambles of Germany and he saw many ruined towns. Even the prisons were sometimes hit by accident. He used to see the American planes coming over and there were no German planes to intercept them. The Russian and Polish prisoners had little spirit and were subjected to brutal treatment. He saw one G.I. attacked by a guard, draw a knife on him and bluff him to standstill. Going through France they found many of the French to be German sympathizers. They fought from buildings with German snipers and fired on Americans. They also acted as decoys going ahead of American troops and leading to German soldiers in ambush. The Americans solved this by shooting down all French decoys on sight.

On their march through France and in Germany the people along the road called them swine and threw things at them. Glenn and his fellow prisoners were released by the 9th armored division. His fellow prisoners were from Ohio, Indiana and Chicago. There was a boy from Saginaw but he does not know his fate as he was sent to another prison. His sergeant, a Battle Creek man was killed at Brest. Before the battle he and Glenn shook hands and it was agreed the survivor should call on the others wife if he got back to America. Sanitary conditions were very bad at the prison camps. The places were alive with lice, cockroaches and other vermin and there were no bathing facilities. Glenn has three cockroach bite scars on one leg as big as half dollars.

Glenn goes from here to a rest camp at Miami, Florida. He does not expect any more overseas duty.

In 1943 we made 99 placements in 1943 and so far this year we have made 125 placements and we are still to rely on the Victory Farm Labor Board from 14 to 17 years of age. We placed 22 last summer and expect to place more this year. We have 12 calls right now and are working on them daily. They will be filled as soon as school is out.

Michigan Mirror State News

State News Gathered from Over the State of Michigan

If Michigan consumption of brewers yeast, rich in vitamin B, becomes a national phenomenon, don't be too surprised.

The health vogue has spread at Lansing to numerous state officials and state legislators, all with apparent beneficial results. One prominent official, up the capitol stairs at a brisk gait thanks to downing a teaspoon of brewers yeast daily for several months.

Here, the story which begins in Washington D. C.

When Dr. William DeKleime became national medical director of the American Red Cross at Washington some years ago he was given a chore of combatting a rising curve of pellagra deaths in the South. A serious regional menace, pellagra was due to lack of vitamin B in the diet. Some whites and Negroes who preferred, by long custom, and family custom, on a combination of 'sowbelly' pork locally known as white meat and corn bread.

These products are all right as part of a diversified diet, but a steady fare of them results in a chronic disease characterized by skin lesions, gastrointestinal disturbance and nervous symptoms.

Dr. DeKleime knew he couldn't persuade by educational methods the Southerners to abandon their diet. So upon the recommendation of Dr. Joseph Goldberger, he chose brewers yeast as a supplementary food. Result: The American Red Cross purchased brewers yeast literally by the ton and distributed it free to low-income dwellers in the sowlbelly corn bread belt. Pellagra decreased promptly as a regional disease, and is now almost at the vanishing point. Perhaps you remember now reading about it in the press and magazines.

In 1944 when Governor Kelly was confronted with the necessity of choosing a new commissioner for the state department of health he invited Dr. DeKleime, a native of Grand Haven to accept the position. Public health work was not new to Dr. DeKleime. He had served a non-official in Flint and Saginaw and thus knew the health problems of Michigan residents.

For some years the present state health commissioner has had private ideas on his own due to private observation and studies about the value of living on a nutritional basis, he calls it. And like many other medical men fearful lest the public might jump to erroneous conclusions he had hesitated to publicize them.

Then came World War II, and the astonishing discovery that approximately one third of all the young men called up for draft in the United States were unfit for military service much of which was the result of faulty nutrition. The medical division of Selective Service pointed out that in one state where people ate fairly well only three men out of ten were rejected for physical deficiencies. In another state where standards of nourishment were very low the proportion of rejections was seven out of ten.

Hence the advent of the "basic seven" program of modern nutrition, blessed by the federal government, enthusiastically pushed by extension divisions of educational institutions like Michigan State College, and generally acknowledged by the medical profession. And here it is on a daily minimum.

MEMORIAL DAY FLAGS

Before Memorial Day a flag will be placed on the grave of every veteran buried in Livingston County it was announced today by Frank D. Bush, chairman of the committee which has handle this job for several years. Committees of the Brighton, Fowlerville and Howell posts and patriotic citizens also assist in this work. There are nearly 1,000 veterans buried in 54 different cemeteries throughout the County. Approximately 225 veterans, including two of the Revolutionary War are buried in the Lakeside cemetery in Howell. Flags will be available on May 1st. Those persons who have assisted in this work in the past are requested to call or send for flags at the Register of Deeds in the county building.

CURRENT COMMENT

The State is watching with interest the progress special prosecutor Kim Hooper is making in solving the day-after assassination of former Senator Hooper of Albion. Their interest is not especially in the fate of the four Detroit purple gangsters who have been bound over for trial for the crime. This gang, has defied the law all their lives in many and devious ways with murder a principal sideline. Their assistance and defiance at their hearing at Battle Creek has set the entire community against them to such an extent that their attorney has asked for change of venue. The main question the people of Michigan want answered is: "Did these gangsters receive 25,000 for arranging the murder of Senator Hooper?"

2, 1945, who put up this money?" Senator Hooper was to have been the principal witness against Frank McKay of Grand Rapids, Floyd Fitzsimmons and Senator Green in a race track conspiracy case and in practically every article on the Hooper case, the name of McKay appears. Fitzsimmons and Green have already been convicted on another bribery charge. Sigler has promised reverentations that will rock the state and the public is with him.

The Detroit News recently remarked: "Everybody will be for President Truman until he does something." How true. Well last week he did something and we will now listen for repercussions. The president has said "No" to Senator George's demand for a general tax cut and down the line especially for corporations and industry. The president's 1945 program has obligations to 85,000,000 war bond holders of the nation and it is our duty to protect them against inflation. He also turned down the appeal of Senator Taft for abolition of lifting of OPA regulations. The OPA is the safety valve of the nation and abolishing it would result in uncontrolled inflation of prices and wages and head us for another depression. We should congratulate ourselves that Senator Taft was not elected president back in 1940.

We wish that those who are proclaiming that the end of the war with the Japs is just around the corner or few months away would face the facts. The statement that one G. I. can lick 10 Japs is classed as bunk by all returning G. I. boys we have talked with who have fought the Japs. Although it was three years ago when Americans invaded New Guinea, the Japs still hold part of the island. Their stubborn resistance on Iwoldima and Okinawa where the American forces suffered their toughest fights of the war and had the most casualties is proof of that. The Jap soldier can live on very little food and is glad to die in battle. They now have most of the vantage points in China, Korea, Manchuria, Borneo and Java and the end of the war with them is far distant.

The Detroit Free Press is conducting an all out campaign against Gov. Kelly of Mich. and his handling of the liquor question especially his appointments to the state liquor control commission. It accuses him of playing politics and catering to the liquor vote by letting the liquor dealers do about as they please. There is no doubt but that the governor has political ambitions and would like to go to the United States senate. Until 1945 the way was apparently open for him and he expected little difficulty in taking the nomination from Senator Vandenberg in 1946. However since Jan. 1, things have been ever a great change. President Eisenhower picked Senator Vandenberg as his choice for the bi-partisan commission to draw up the peace project at San Francisco and assisted in his build up until today the Michigan senator is one of the world authorities on international affairs. Undoubtedly he will accompany President Truman to Europe when the final peace treaty is drawn up. All of this leaves Gov. Kelly dangling in the air. He can hardly expect to beat Senator Vandenberg now. His only alternative is a third term for governor which will not suit Vern Brown because he also has his eye on the governorship.

Milk—Adults: Two or three cups daily. Children—Three or four cups cups daily.
