News and Happenings of the State Told from Lansing

Hottest issue in the forthcoming campaign is the sales tax diversion amendment to the state constitution. This amendment is adopted by voters Michigan schools will receive approximately 100 million dollars. Last year they got 60 million.

Mich. Ed. Ass'n. first opposed amendment out are now for it and making a vigorous campaign.

The proposal was the outcome of legislative demands by mayors of Michigan cities for a split of the Michigan sales tax.

The cities were defeated by the rural members of the legislature in their attempt in the last legislative session and saw they must get other groups behind the amendment. Accordingly they worked it so that they made it attractive to the schools.

Under it the schools would receive 16 1/3 percent and the cities, villages and townships a similar amount.

As an added inducement to school the diversion amendment was worded so that the schools will continue to receive their regular annual grants in addition to this new 16 1/3 percent of the sales tax.

The present state aid to schools is equivalent to 4 1/2 percent. With the new 16 1/3 added this would give the schools 60 percent of the sales tax.

For years the Mich. Educational Ass'n. has conducted campaigns at each legislative session for more aid to schools and usually got it for the schools are dear to the hearts of the people.

If this amendment passes further lobbying will be unnecessary as the schools will be assured of more money than they ever had before for many years to come.

And the schools are right they must have more money. Allan Schoenfeld, Detroit News writer made a detailed study of the school situation. His conclusions were: 1. The Mich. school system is being a complete collapse. 2. Teachers are underpaid. 3. Quality of the teaching staffs is fast deteriorating. 4. The 15 mill limitation has become a modern strait jacket. 5. Modern school buildings are presently needed.

The \$270,000,000 veterans' bonus must be paid out of taxes too.

If both the sales tax split and veterans bonus pass more taxes are inevitable.

PINCKNEY TEAM RECORD

In 1944-45 Pinckney had little material to choose from and the refrain was "just wait until the boys get back from the service. Of the pitchers Bob Singer won 13, lost 4, Stanley Dinkel 7 wins 2 losses, Paul Singer won 1 and lost 2. The latter was injured twice and played the outfield mostly. Bennie VanBlaircum caught 2 games, Edsel Meyer 3 and Wesley Reader the rest.

Home run hitters were Joe Lavey 10, Paul Singer 5, Fred Singer 5, Gus Ledwidge 3, Jack Reason, Roy Reason, Edsel Meyer, Wes Reader, Bob Singer and Keith Ledwidge 1.

DRAFT BOARDS RESUME WORK

Michigan draft boards resume work Sept. 1 and during this month 1,597 men will be inducted. Non-fathers 19 to 30 are subject to military service. A father is defined as a man supporting one or more children. A more strict occupational policy is in force and the students can only get induction postponed if they are in title last half of their high school year.

Veterans are subject to induction if they have had less than 6 months service or no foreign service.

Although 19 is the minimum age all boys must register on their 18th birthday.

A bad accident took place Tuesday afternoon on the Patterson Lake road west of Ludley Vansickle's home. 
