

Michigan Mirror

In his new crusade to make state commissions and bd.'s more responsive to the voters, Gov. Kim Sigler is again in the role of a bold reformer, a knight in shining armor, astrid a traditional white horse, giving battle gallantly to the forces of entrenched vested interests... this time, state bureaucracy itself!

Here is an issue obviously cut out for Michigan's fighting governor. There is little doubt that he will try to make most of the opportunity during 1948, an election year.

The governor's announcement that he will seek to make directors of commissions and boards responsible directly to him, and in turn dependent on the State Senate for appointment, was made in the triumphant wake of a successful legislative session. There the governor displayed new and aggressive powers. No longer was he content to submit his recommendations and then leave solo to their own prerogatives, thus keeping the executive branch separate from the legislature branch, as he has done earlier in the year.

With the aid of late G. O. P. chieftains, he applied the pressure convincingly and effectively. A 32-page bill abolishing the corrections comm. and replacing it with a non civil service appointee, was considered briefly by the Senate judiciary committee, sent without change to the floor explained for six minutes and approved 25 minutes later. That is speed!

Observers have pointed out that the present position of the governor is a reversal of his earlier stand regarding the comm. Last May he indicated that the corrections comm. was one of the best in the land. He asked Austin H. MacCormick, executive director of the Osborne Ass'n, and a noted penologist, to appear before a legislative committee that was considering a bill to revise the Michigan set-up. MacCormick declared that Michigan's system was a model.

With his Nov. bill approved over whelmingly by the legislature, Sigler then disclosed that he would ask the legislature to vest power in the governor to appoint comm. directors, subject to Senate approval.

The governor feels that Mich. has too many commissions and bd.'s. Some should be abolished outright; some should be retained. Those worth retaining should be held responsible direct to the governor who now, Sigler says, is little else than a glorified clerk.

He specifically refers to the state conservation dept. as being a kingdom unto itself, free from political control. Whereas the director now holds office at the will of the comm. under the Sigler plan he could be reappointed or fired every 2 years at a turn of the political tide.

Therein lies the great weakness in the governor's armor. For the past 18 years only one Michigan governor or -- Harry F. Kelly -- has served two successive terms. Every 2 years with one exception, a new governor took office. In the dept. of agriculture the result was a new director every two years with appalling regularity. This lack of continuity prompted legislation spurred by farm organizations, to take the directorship out of politics and into the hands of a new commission. Chas. Flyg a Kelly appointee was renamed director.

Conservation Notes

Arrests for deer hunting violations total an even 1000. Emergency messages delivered to deer hunters total 150. Rain and snow curtailed deer hunting and the number of hunters the second week was much less than the same period a year ago.

To date \$28,705 in bounty money has been paid for foxes. 21 deer were shot by archers in Allean county this year. 140 hunters killed 251 sharp tail grouse on Drummond Island this year.

Bid are being advertised for concessions at 19 state parks. Waterloo and Pontiac Lake were added to the list for next year. The bids are 10 percent of the first \$7,500, 12 one half percent of the second and 15 percent of all over \$15,000.

Deer figures compare favorably with last year. Hunters got 1044 permits to take deer through Wisconsin this year compared to 784 last year. Drummond Island yielded 500 deer compared to 452 in 1946. 8936 were brought across the straits this year and 8657 last. Bear showed a decrease 152 being killed this year and 234 last year. Rabbits are said to be free from typhlocystis this year.

The dept. is making a timber survey in Jackson, Barry, Branch, Calhoun, Hillsdale & Allean counties.

Current Comments

Those who are against bringing back the bodies of the soldier boys from overseas claim that the boys who gave their lives are all buried in French, Belgium, German and Holland cemeteries and that their graves are reverently taken care of and decorated with flowers by the grateful people there. G. I.'s who served in those countries dispute this. They say that land for agriculture is very scarce and valuable there. The people are very poor & every foot of land is put into crops. The people resent the fact that so much valuable farming land is taken over for cemeteries. Farming is still carried on as in grandfathers day & machinery and fertilizer are hard to get. Human excrements are saved and so is the urine of the horses and cattle there. When this is put on the land the odor is almost unbearable.

Although Michigan and Notre Dame football teams do not meet this year, still a good comparison is possible. Both teams play U. of Southern California. Notre Dame on Dec. 6 and Michigan at the Rose Bowl, on New Years Day. Michigan and Notre Dame are rated the two best teams in the nation and Southern Calif. is given little chance to best either. Michigan is classed as the No. 1 team one week and Notre Dame the next. The Ass'n. Press All American football team had one Michigan man, Chappius, on it & 3 Notre Dame players.

One battle looming in congress is between big business and the co-operative companies. Big business is taxed but the co-ops are not. The latter escape taxation by the fact they claim to be non-profit organizations. who sell goods to members at cost only charging enough extra to pay operating costs. Big business denies this and says the co-ops made sufficient money to expand greatly and erect large modern buildings. There are 13,500 such co-ops in the nation, mainly farm and city consumer types. If taxed they would yield the government \$13,000,000,000.

A Philadelphia butcher has worked out a system to cut prices. He signed up 300 customers who pay him \$1.25 a week. In return for this he sells them meat, eggs, butter etc at cost. If he can get 500 customers he will cut the fee to 75c. He claims average markup on goods is 35 per cent and those who in his organization will save 25 percent.

Our debate with Russia goes merrily on with all the commentators and writers taking pot shots at Russia and yelling "sic em". Russia is ed several American troops last week in Europe who ventured too near the Russian border but efforts to make an incident of it collapsed when they were released unharmed a couple of days later. We are of the opinion we will back into this war in the same manner we did into the last one. On that day of Dec. 7 1941 most people had just finished dinner and sat down to get their favorite radio program when the radio lanes were filled with news of the sneak attack on Pearl Harbor. Inside of 24 hours we were at war not only with Japan but with Germany and Italy.

The County Press editor does not like the old age pensions or social security systems. He thinks they encourage shiftlessness and are wasteful. It was ever thus. The difference was in the old days the town ship or city paid. Now they get federal funds. We remember back in the days of our youth, persons who got relief were said to be "on the town". The number fluctuated but always rose in the winter when there was little employment. The supervisors who handled this relief were usually able to build up a political machine by putting families on the town in return for their votes. In some cases they furnished food, fuel, rent, doctors services and even funeral expenses. Old timers here still relate the case of a man on the town who was sent a load of 4 ft. wood and refused to accept it because it was not sawed up. The poor we have always with us.

Social Security was devised to aid factory workers who in many cases got less than 9 months steady work a year and had to take long layoffs without pay. This was the big issue in 1934 and Alfond Landon who opposed it carried but 2 states. Old age pensions were voted by the different states to aid old people who had nothing to live on their old age. The Michigan legislature voted one in 1924 and most other states followed later. Some thought of using the proceeds of the automobile tax to fund it.

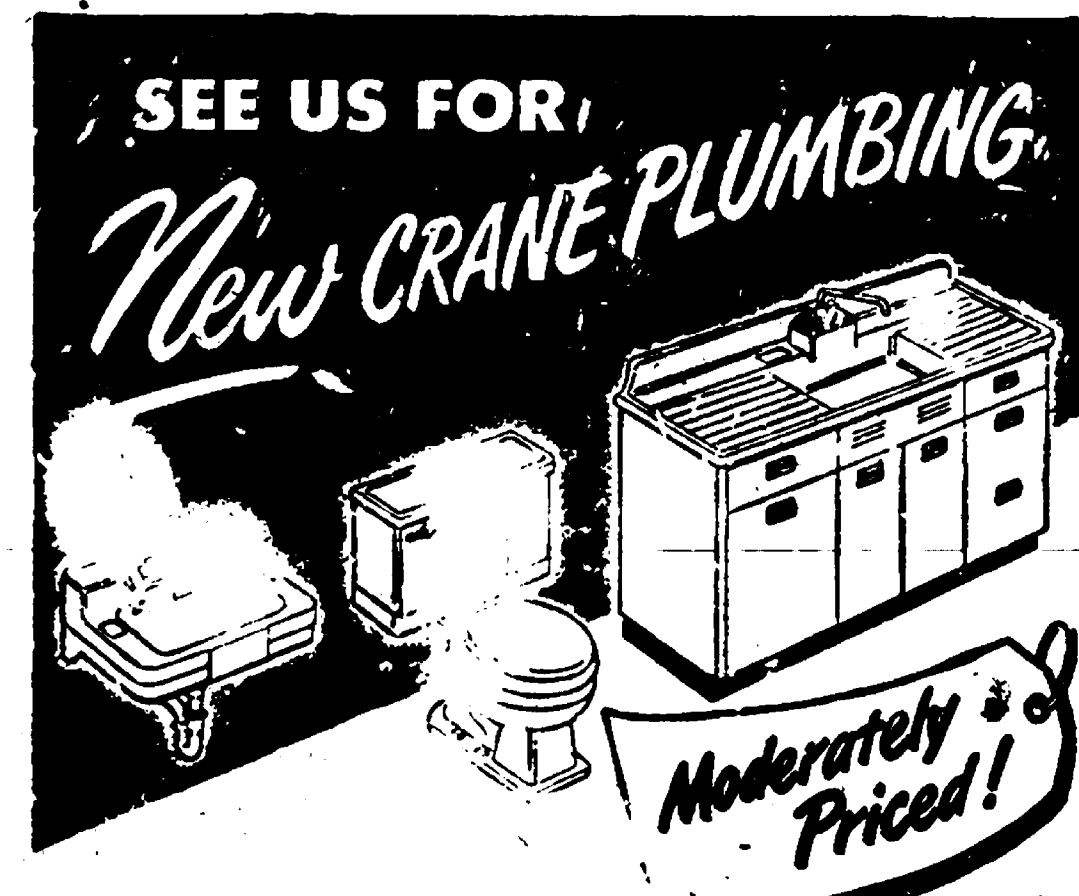
