Michigan Notes

In the old days it was considered smart to put out sensational story in the last days of a campaign when it was too late for the other side to deny it. Last week Malcolm Bingay of the Detroit Free Press came out with a first page story to the effect that Gov. Dewey's failure to speak in Detroit was caused by his fear of being subpoenaed to testify in the grand jury investigation of the auto dealers donations to the Republican campaign fund.

Gov. Dewey's steadfast refusal to come to Michigan is a sore spot with Michigan Republicans. Gov. Dewey at once branded the Bingay story false. He said the only reason he did not come to Detroit was that it did not fit in with his plans or schedule. Attorney Gen. Clark in charge of the of the investigation also branded the story false and said if they had wanted to subpoena Dewey they could have did so the Saturday he was in Owosso.

The reason Dewey did not come are he has never forgiven Michigan for joining the Stop Dewey movement at the Philadelphia convention by putting Senator Vandenberg out as a dark horse candidate. Also all straw votes and forecasts show the Democrats will carry Wayne county & he figures it would be wasted time.

Telephone Rates

The Michigan Public Service Commission has approved an increase in rates for the Michigan Telephone Co., increasing the company's revenue \$8,217,000 a year.

Effective immediately the rates which, after taxes, will mean \$5,084,540 to the company will be applied to each of the company's 242 exchanges. It is the first rate increase in 22 years. The order establishes 2 sets of rates to outstate exchanges including Pinckney where extended area service will be established. The first is an interim schedule until service is established. The other the new rate when extended area service is established. Although this new area service was approved in April it will not get under way until late next year.

This new service will give Pinckney subscribers the privilege of making unlimited calls to Brighton, Dexter and Howell without paying toll. Introduction of this service will not increase the company's revenue as such increases will be offset by loss of toll revenue.

The new order authorizes higher increases in some exchanges including Pinckney to correct inequities. A commission order in 1942 dissolved such inequities where rates were too high but failed to raise them where they were too low. Pinckney was one of the exchange on the low rate side.

The Pinckney increases will be as follows: Residence service from \$1.50 per month to \$2.25 when extended area service is introduced \$3.00. 2 party lines \$2.50; 4 party lines \$1.25 to \$2.00 rural now \$1.50 to \$1.75, extended area \$2.00.

Business Service private line exchange \$2.40 to \$6.00, extended area \$8.25; individual line now \$2.00 to \$5.50, 2 party \$3.25 to \$4.50; rural \$1.50 to \$2.75, extended area \$3.50.

Rates or residence extension phones 60c to \$1.25.

Long distance calls increased 6 percent. Initial calling period reduced from 5 to 4 minutes for 3 minutes from 15 to 30 miles, distances from 10 and 15 miles.

Overtime charges increased from 1-4 to 1-3. 5c increase on night and Sunday calls for distances of 48 to 112 miles. The increases will provide the company with a 6 percent return on its investment.

The company started a large expansion program to cost \$220,000,000. This is half completed. The rate increase will help finance it and also provide for the wage increase granted employees last year. Further wage demands would raise the payroll costs by \$6,700,000 a year.

The rate schedule classifies exchanges into 8 groups depending on the number of phones. These range from those with 800 phones to those with 100,000.

The last Pinckney score came in the last quarter when Bob Amburgey caught a lateral pass and ran 40 yds. for a touchdown. South Lyon intercepted a pass in the try for extra point.

Then the second team went in. Against the kids South Lyon got some gains on running with the ball and finally McCormick went around Pinckney's end for a touchdown. They failed to kick goal. The Pinckney kids showed lots of fight and twice took the ball on downs.

Joe Jeffreys punting was high class and Jerry Heath did some nice line plunging. Good's passing was accurate.

Next Friday comes the game of the season when Dexter will come here accompanied by at least 500 fans. If Pinckney can manage to win this game their season will be a success. Last year Pinckney held Dexters championship team to one touch down to the last few minutes of play when Dexter intercepted 2 Pinckney passes to score twice more. Current Comment


With the election just around the corner Republicans are not as certain of a Dewey landslide as they were 60 days ago. Undoubtedly President Truman has gained ground during his western campaign trip. How much is the question. He is a much friendlier person than Gov. Dewey whose coldness and aloofness has not clicked with the people. Straw vote takers and political forecasters all concede the election to Gov. Dewey but by a strange quirk say the Republicans will lose the Senate. A number of isolationist Senators who have spent their time obstructing every progressive measure presented are up for reelection and according to a forecast are due to get beaten. They are Republicans. Gov. Dewey's refusal to campaign in Detroit has not set very well with Michigan Republicans. The Republican congressmen are shown to be trailing there and Dewey has been implored to help pull them through. To these pleas he has turned a deaf ear. Charles Roxborough, negro lawyer and Republican National Committeeman says the Democrats will carry Wayne County by 100,000 as they will get the bulk of the negro vote. The negroes do not like Dewey as he has not recognized their race by appointment or come out for equal rights. Truman's chief weakness is the south where the Dixiecrats may take 45 sorely needed electoral votes away from him.

Parking meters may not be the answer to the revenue problem of the small town or city. In Brighton and Howell they seem to have brought trouble. The police officer in Howell was recently dismissed for failure to enforce the parking meter law. In Brighton, affairs are even worse. The police chief there when called on the carpet for failure to enforce the law claimed the meters were defective, being second hand when installed and that if he issued tickets for violations he would lose every friend he had. These meters evidently work out in cities like Ann Arbor, Lansing and Jackson where most of the parking is done by out of town shoppers. Where local shoppers predominate the reaction is not so good.

The Pinckney high school football schedule needs revising before next year. The Hartland and St. Mary's Adrian games do not draw and little interest manifested in them. Last year only a handful of people saw the game with Hartland. Adrian is too far away and they bring few fans with them when they play Pinckney. The two teams which should be on the Pinckney schedule are Fowlerville and Chelsea. Pinckney used to meet them every year and has beaten them. Both have lighted fields and would bring a bunch of fans with them. Maybe Pinckney could not beat them this year. Mich. State knew she had little chance against Notre Dame but put them on her schedule because she knew they would fill her stadium for her. The Pinckney teams after a run of 18 straight victories in Coach Reider's first two years hit a slump the last two years, but they have had other slumps before and have always come out of them.

The workers class which was recently discontinued at the University of Michigan over the objections of Pres. Ruthven is assuming significance in the campaign for governor. This course was inaugurated 2 years ago to teach the relationship between employee and employer. Prof. Adler was the head of it. Last spring representatives of the General Motors visited Gov. Sigler and protested against it claiming Marxist doctrines were being taught. Both unions and Gov. Sigler agree on the story so far. The unions charge Gov. Sigler abolished the course. The governor says he ordered the reports to make an investigation and they abolished it. Apparently the bus and cry against the action was so loud the reports have promised to substitute for other election. However, they first find the head of it. Prof. Adler.

SPARE THAT TREE!— Graduate foresters at Michigan Bell are in charge of trained crews that trim trees and control brush which might menace telephone lines. They work with utmost care to preserve the beauty of trees and landscape. Thus far this year, tree trimming and brush control have involved 45,000 man-hours.

"BLIFFY SNIFFER"— It's the nickname for a sort of "electrical bloodhound" used by telephone men. When work needs to be done on a certain pair of wires in a cable, an electric tone is placed on those wires at the central office. Out on the cable, the "Bliffy Sniffer," a pencil-like instrument, quickly picks out the wires by detecting the tone they carry.



U.N. General Assembly Meets




