The Michigan Mirror

Michigan is slowly recovering from the great recession of 1958 but it will be months, even years before there is full recovery. The state unemployment fund ran low during that period and it will be a long time before the trend was reversed, hardest hit was the public welfare system and taxpayers will be paying the bill for months. Nine counties ran out of money before Dec. 1. The largest one was Muskegon that became a classic example of economic distress some years ago. Counties normally pay 10% of the welfare fund and the state 30. Generally more jobs are available in the summer but there were not this year. Conditions worsened and it is predicted the deficit will be \$15,000,000. They have now asked for a program of federal state and local aid of \$179,473,204 for 1959-60, a jump from the inadequate one of \$125,490,359 for the fiscal year. Price of the social problem will soar from \$55,494,500 to \$61,955,380.

Cost of state institutions under the social welfare dept. will increase from \$4,226,310 to \$6,420,706, most of it going to the new Boys Vocational school at Whitmore Lake.

This is only one phase as the mental hospitals are overcrowded and so are the states prisons. Public health services need expansion and the states colleges and universities facilities are long overdue for a raise.

The situation is further complicated by a campaign to revise the sales tax. The tax on beer, now \$1.25 a barrel may be doubled. Others favor an income tax.

Michigan's dept. of labor is a misnomer. It has nothing to do with labor disputes, compensation or security. Their sole duty is factory safety and child labor.

An estimated 92,000 deer were taken in Michigan in 1958. This is the highest since the 1953 mark of 99,500 and an increase over last years 79,435. 12,000 were brought across Mackinac Bridge compared to 9220 last year. The antlerless kill is set at 15,000. The dept. is head hunting for the largest deer rack. So far the largest ranks 88th compared to those on record. If you have a 10 point with an inside spread of 20 inches notify the dept.

However this is only part of the Christmas mail problem. Names and addresses are carelessly written, packages are poorly wrapped or have insufficient postage. This results in delays, disappointments which can be avoided if everyone will follow the following simple requirements:

*Wrap your gifts securely.
*Address cards and gifts correctly.
*Use complete addresses, including street number, rural route or post office box number. Be sure it is complete with avenue, parkway or drive spelled out. Avoid abbreviations. Use zone numbers when possible and include your own zone number on your return address.

*And most important of all, Mail your cards and gifts within the next few days. Delivery of Christmas cards will be expedited if you bundle them with Local or Out of town bands available at the postoffice.

The postmaster also suggests that you mail all Christmas Cards first Class all insuring forwarding service if the addressee has moved or the recipient cannot be located. Then too you can include handwritten messages to make your greeting more personal.

WHERE THE MONEY GOES
It is a fact that the farmer's share of the food dollar has declined. What is the reason?

The 1957 report of the American Institute a packer organ give the following figures: In 1947 the packers spent 80.6 cents of every dollar on livestock and raw materials. In 1957 the figure was 73.6 a drop of 8.7 percent. In 1947 the packers profits were 1.5 cents on a dollar. In 1957 they were seven tenths of one cent a drop of 53 percent.

The answer is that costs, wage, transportation, packaging material, depreciation have gone up. The public has also developed a taste for frozen or processed foods which cost money to prepare. Still the packer now spends 56.5 of the dollar on livestock.

Current Comment

It is a dull day when there is no some flareup in the milk business. The milk wagon drivers went on a strike last week and refused to deliver milk from house to house due they said to unfair competition by supermarkets who they claimed were selling milk below cost. In some cases \$10 a month less than wagons could deliver it. This cut down their sales and they want the practise stopped. There's a law about unfair competition but we do not know as it applies to milk. They will probably try to get a law introduced in the legislature.

Gov. Williams will appoint a commission to work out a plan whereby some of the mental cases for whom there is no room will be transferred to the Gaylord TB Sanitarium where there are empty beds. The Howell Sanitarium was also mentioned 2 years ago when the same question came up. Besides these there are sanitariums at Traverse City and Marquette. The move was blocked then by the TB board who denied TB cases were decreasing. They wanted compulsory TB examinations which the legislature would not approve. The evidence points to a decrease in TB cases. Many TB hospitals, some built by the counties, have been idle for years.

Following the parochial school fire in Chicago last week in which 89 children and teachers lost their lives, many papers ran editorials entitled "Could It Happen Here?" The consensus was it could. Detroit alone has 42,000 children in non fire proof schools. Most of them are of wooden or brick construction built 50 or more years ago with open stairways which act as a chimney in case of fire. In the Chicago fire most of the victims suffocated. Some were killed when they jumped from upstairs windows. Then why are not these old fire traps replaced? There are a number of reasons. No. 1 reason is the cost. It would be hard to raise enough money. No. 2 is that they are all urgently needed due to the soaring birth rate which followed World War I. They are building new schools, not tearing down any. The old school here is not fire proof and has an open stairway. During the late war the board was ordered to put in fire doors to shut off the new part from the old. They were ordered but due to the war they could not get delivery and they have never been installed. An outside fire escape was put up two years ago. The state police who enforce the fire laws inspect the buildings regularly. Now days most new schools are built one story high with plenty of playground and parking space. This eliminates a lot of fire hazard.

The new tax plan to be presented to the legislature is being assailed and it might end in a stalemate with no bill being enacted. The principal objection is to the graduated income tax which some lawyers call unconstitutional. Also the proposal to cut the sales tax would have to be put to a vote of the people. In this state the low income groups, those earning \$3,000 a year or less pay 12 to 20 percent of the taxes, counting the sales tax while those in the high income groups pay 5 to 7. The law allows \$4 a year per person to be deducted for what a family pays in sales tax. A family of 4 would get a nice rebate.

A new Republican candidate for governor in 1960 has appeared in the person of George Romney, head of the American Motors. Maurice Clink of Detroit is the head of it and he says Romney for Governor Clubs will be formed all over the state. He is a stormy petrel in politics like Harold Stassen and in 1956 supported Dan Leonard for governor against Mayor Cobo in the primaries.
