Educators are holding their breath in hopes House bill 91 passes. This encourages the consolidation of schools too small or poorly financed to offer 12 full grades of school. If this does not produce consolidation the supt. of public instruction is empowered to do so after a waiting period of 2 1/2 years.

The program is favored by most education authorities because it provides more education for less money. Those opposed say it takes local control away from school districts. This argument might have stood up when the schools were competing financed by the districts but now most of their money comes from taxes spread over the entire state. Today 89.9 % of the children in Michigan attend 12 grade schools.

There are 2,360 schools in the state of which 545 are 12 grade ones, and 1815 offer less than 12 grades. Financial shortages are fast putting the district schools out of business. The state equalized valuation for school districts has increased \$3,196,002,600 since 1957.

Farmers are welcome in Alaska but dreamers without money are doomed to disappointment. Officials say persons wishing to homestead should have \$5000 for the first year. Prices are higher there than here.

The legislature passed a bill making empty beds in TB hospitals available for mentally retarded patients. Convicts in prison suffering from TB will also be sent there.

TEARS UP PRESCRIPTION BOOK

Dr. L. E. May of Howell is the state chairman of the Bagwell Boosters for Governor Organization of Michigan. Recently he decided to write a few prescriptions to boost Bagwell's chances for governor next year. In them he suggested a committee to pick a candidate for US senator to oppose Pat McNamara Higgins of Ferndale. It had Bagwell's name signed to it. Senator Higgins sent the letter to Cong Bentley of Owosso, the only one out for the senate so far. Bentley blew his top and accused Bagwell of trying to dictate the nominee for senator. Bagwell when called disclaimed all knowledge of the letter. Dr. May took all blame for the letter and offered to resign and Bagwell has been trying to mollify Bentley.

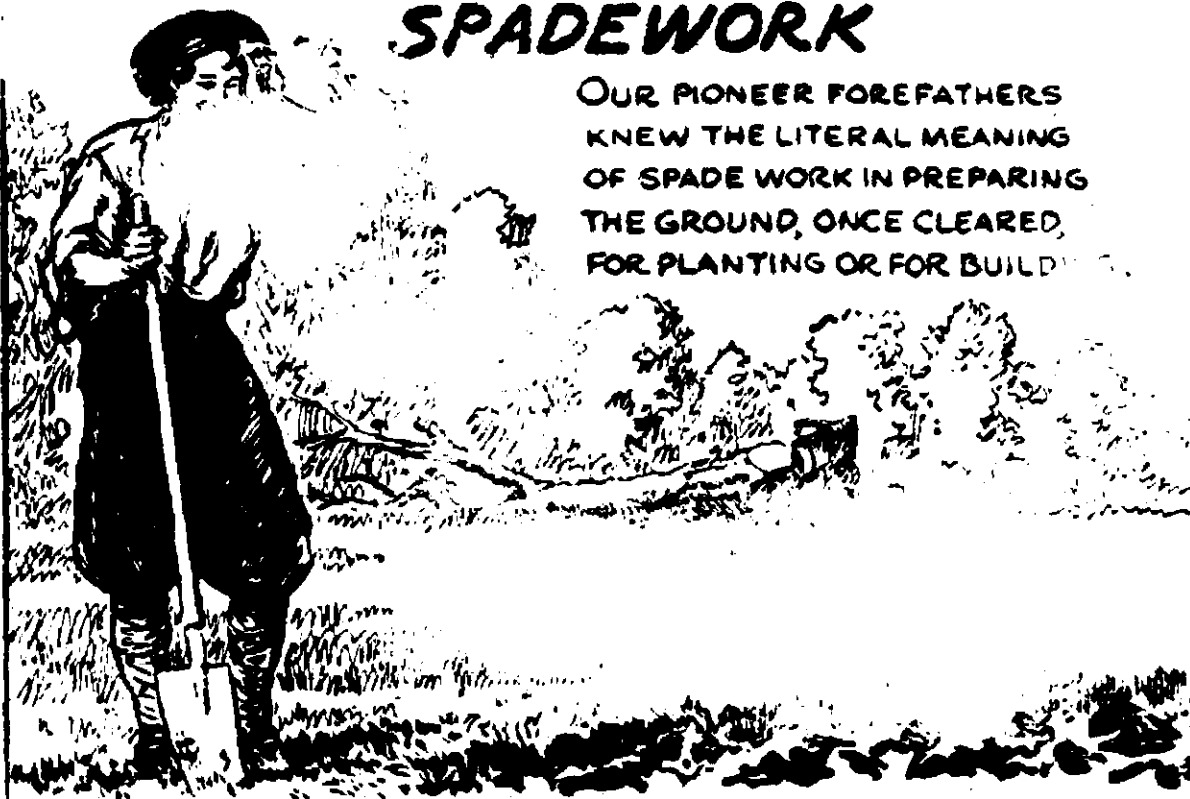

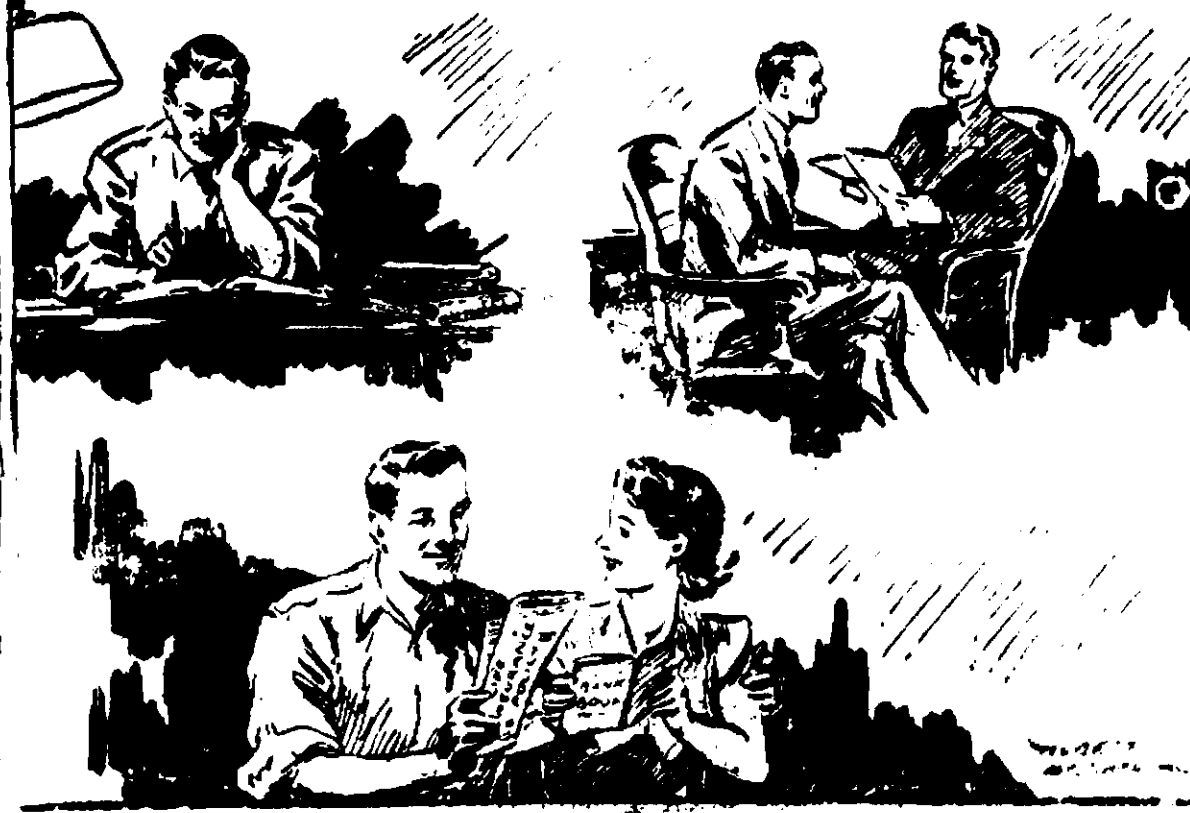

Current Comment

The Michigan legislature is still marking time and State Treasurer Brown says there will be no more paychecks for state employees or persons on welfare. The senate killed the plan to use the \$50 million dollar veterans trust fund but it may be bought up again. The session was convened when Rep. Conlin Republican, chairman of the tax study committee blasted the Michigan Manufacturers Ass'n. and their director, Charles Crighton for attempting to discredit the work of his committee by press releases and intolerant language. He said the MMA was a rift stone around the neck of the Republican party. Rep. George Hall vice of Ann Arbor also took a swipe at the MMA and threatened a damage suit. They blasted him because he introduced an income tax bill and implied reprisals against the Wahr book stores in Ann Arbor owned by his mother. The MMA evidently does not want any kind of an income tax. Paul Bagwell tried to get one in the Republican platform last fall but the platform committee under pressure threw it in the waste basket.

Gov. Nelson Rockefeller of New York vetoed the bill to permit the teachers of New York state to use corporal punishment to enforce discipline. The bill would have taken the decision away from the school board and placed it with the teacher. The governor says he believes in spankings but thinks the decision should rest with the board. This puzzle is a bit. Does it mean that a teacher must wait until the matter is submitted to the board before a spanking could be inflicted? Would they call a special meeting each time the question came up or would they let them accumulate and act on them at the regular meeting once a month. If they did that a teacher might have to take a day off to get her spanking docket updated.

During the French revolution the fishwives of Paris, many thousand women, fished in Paris and took over the cleaning and selling fish. The march of the 200 grandmothers on the Ford Motor Co. last week remind me of them. These women were hired during labor shortage of World War II when Rosie, the Riveter rose to fame. They have been employed on various jobs since and have attained high seniority. During the recession they were laid off and have not been called back. They are told their job smelt in the electric plant, no longer exist as they have been sublet out to small factories. Most of them are married and their children are now looking for jobs.

As yet there has been no water shortage here although some wells have gone dry and had to be sunk deeper. There has been court action but it was usually where lake levels were lowered by diversion. In some parts of the nation the scarcity has become serious notably the southwest. Still every part of the nation is using much more water than ever before. The days of the tin tub, the Saturday night bath and the out house are gone with the horse and buggy. Most homes now have modern plumbing. The greatest water users are industry, sewerage irrigation, navigation and power generation. They are using so much that many states are suing other states for using water they claim belongs to them. At present all states but three have water shortages. Water levels are down 400 feet and some wells shortage here although some wells are 1500 ft. deep. This has made water costly and in Arizona 50,000 acres are no longer irrigated. Irrigation has also declined in Texas and New Mexico. The nation uses some 13000 billions of gallons of water a year. It is not all wasted as in some cases industry and power generators return 95 % of the water. Irrigation uses the most as of 120 billion gallons used 20 billion are lost by evaporation. Cities use much surface water for their water supply. In Los Angeles a plant has been built to convert sea water into fresh water. It converts 100,000 gallons a day but the cost is prohibitive.

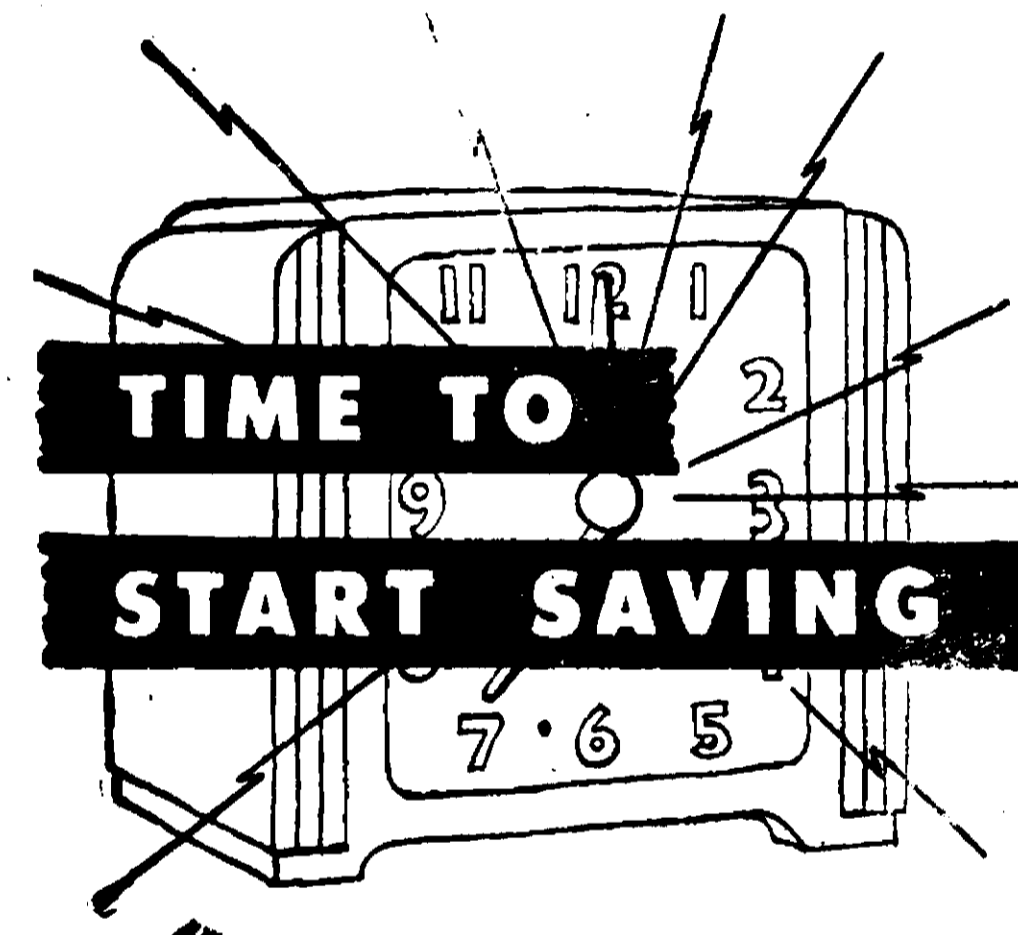
