## Loses Hand in Market Accident

James DeWolf, son of Mr. and Mrs. Fred DeWolf (Helen Stevens) of Hamburg was the victim of a tragic accident Saturday that resulted in the loss of his right hand and wrist. James' hand was caught in the meat grinder at Suter's Grocery, Hamburg, where he is employed. Witnesses said the boy quickly disconnected the electric grinder by pulling the plug from the wall-socket and called for help.

Hamburg firemen and Livingston County sheriff's officers who were on hand for the gala-day celebration going on in the streets of Hamburg were unable to remove James' hand from the machine. They rushed him thus by ambulance to St. Joseph Mercy hospital, Ann Arbor, where he underwent emergency surgery. James is reported to be doing well at this writing on Monday.

James was graduated from Pinckney High school last month and two weeks ago completed his enrollment requirements at Ferris Institute, Big Rapids, where he will study in September.

James has been employed at the grocery store for nearly three years, working part time hours while attending high school here.

## Yacht Club Holds Gala Day Event On Saturday

The sun was bright, the breeze was brisk, the costumes were gay and the boats colorful, as the members of the Huron-Portage Yacht Club gathered at the Ruel Cadwell dock about one o'clock Saturday afternoon for the club's annual gala day.

All NAYRU rules were suspended — except the starboard tack right of way rule — for the "fun" races in which the competitors were given sealed orders. The point system set up to determine the winners gave the first yacht to round "mark 2" 10 points; the first yacht to finish, 20 points; costumes, 5 points; boat decorations, 10 points and five points for each crew member.

When the skipper of each boat opened his final envelope in a set of four, he learned that his boat was to cross the finish line stern first, a feat that was accomplished only by lowering the sails, jumping overboard and pushing the boat over the line.

Declared winners in the Flying Scot class were the Merrimans of Plymouth, a family crew. In the Lightning class the winners by sheer weight were 17 teen-agers aboard the Stevens' boat. Dr. Frank Schwartz of Ann Arbor brought his vessel over the finish line first in the Rebel class. A special award, honorable mention, was given to the John Bartlett family second in this race. The Bartletts, parents and two youngsters, used the theme of "Sailing Down the River" in their dress of the gay nineties beach wear. In the Snipes class the Swisher boat, bearing the "cutest cuties" and executing the "fanciest finish" was the winner.

Following the races Dr. and Mrs. Avery Bartlett were hosts at a cocktail party for the members and at six o'clock in the evening the club attended a banquet at St. Mary's parish hall, Pinckney, to complete a most gala day.

Dr. Bartlett is Commodore of the club this year. Dr. Robert Bird of Wayne was the chairman of the events of Saturday.

Acting as judges were Mrs. Helen Van Blaircum and Mrs. Leila Jackson for costumes and Mrs. Eleanor Douglas and Mrs. Ethel Stevens for the races.

In the Rebels, Gary Davis of Portage Lake, claimed first place, Dr. John Bartlett, second and Tom Ehman of Ypsilanti, third. Two Ann Arbor men, Dr. William Call and Sam Swisher were first and second, respectively, in the Snipes and Lou Barstow of Detroit sailed in third. Dr. Robert Coleman won the Cruising class race.

When the storm struck the lake a Snipe sailed by Leslie Douglas was upset; boats belonging to Dr. B. C. Payne and Dr. Call collided and the Payne boat was damaged but no one was injured.

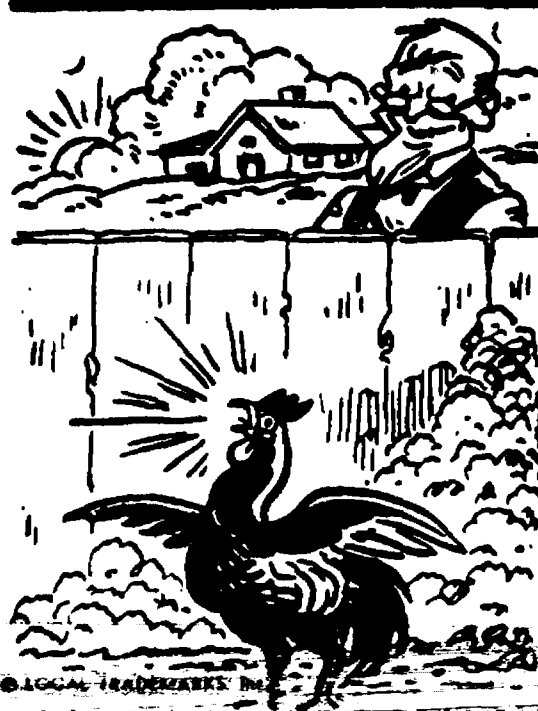

## Auto Power Windows Dangerous

The unattended station wagon with an automatic tailgate window was pointed to as a potential child-killer, by State Health Commissioner, Dr. Albert E. Heustis.

The Commissioner's warning followed several recent incidents, one of them fatal, in which children have caught their heads in an automatic window.

"Children should never be left alone in an automobile under any conditions," Dr. Heustis said. "But a car with automatic windows is a booby-trap. The power of these windows, exerting up to 50 pounds pressure, is enough to strangle a child easily."

"In standard models, the windows work only when the ignition key is on," Dr. Heustis explained. "Removing the keys eliminates the danger."

"But in most station wagons with automatic tailgate windows, the ignition key is not required. If two or more children are allowed to play in such a car, the window can become a blunt guillotine for one of them."

"A lot of people seem to think of a station as a kind of mobile playpen," the Commissioner commented. "It's a dangerous practice."

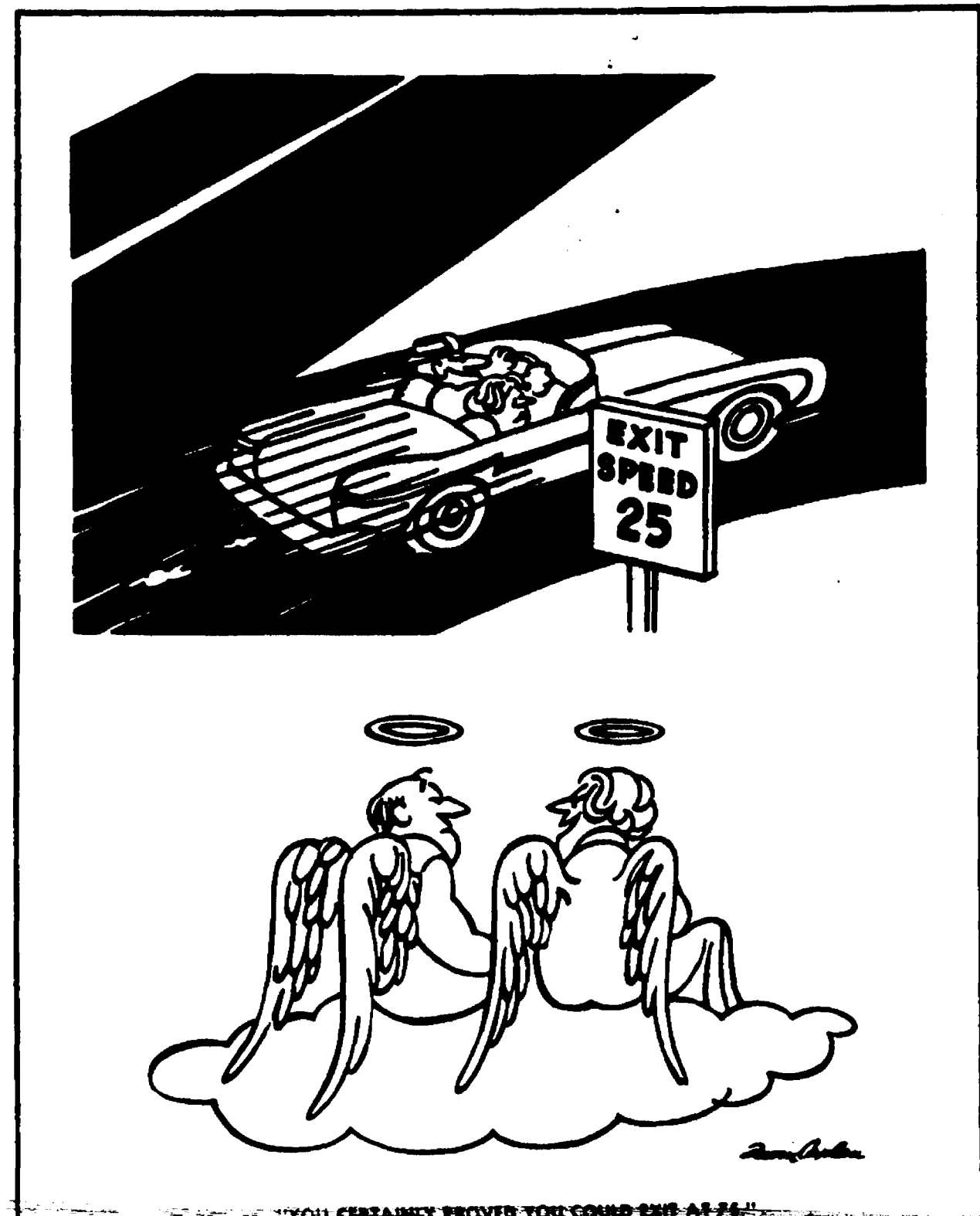
A daughter was born on July 16, to Mr. and Mrs. Mahlon Walker at McPherson Health Center.

## MICHIGAN MIRROR

Litterbugs are a costly segment of Michigan's society, according to State Highway Department maintenance officials. Department records showed it cost nearly \$1,000 a day to keep

state highways relatively litter-free last year.

The litter problem and a proposal to ban throwaway beer bottles prompted the Governor's appointment earlier this year of a committee to study the problems and recommend ways to keep Michigan beautiful.

A "public persuasion cam-

paign" is now being waged by the committee, which named itself the Keep Michigan Beautiful Committee, in an attempt to arouse an awareness of the effects of litter-strewn highways, beaches and parks.

John Murray, Highway Department information officer, was named head of the publicity subcommittee of the group.

"The various subcommittees are working with their respective 'audiences' throughout the state," Murray said. Committee chairman Joseph A. Childs, State Police Commissioner, has sent a meeting this fall to make recommendations to the Governor.

"We have no spectacular plans—we are just doing what we can with limited and willing hands to make known the value of keeping parks, roads and lakes as clean as possible," Murray said.

The "audiences" being approached by subcommittees include industry, chambers of commerce, radio and television, and newspapers.

A major portion of the campaign, for example, is aimed at Michigan motorists. Attempts are being made to have gas filling stations distribute litter bags and keep receptacles handy for motorists.

"The filling station is the one place every motorist has to stop no matter where or how he drives," Murray said.

"A major solution would be accomplished if the motorist had some place to get rid of accumulating litter when he drives, and the gas station now appears to be the logical place."

For the first time in 50 years Michigan will elect a Congressman-at-Large whose constituency will be the entire state.

Few people of voting age today voted for the last Congressman-at-Large elected in 1912, but it's a safe bet that a majority of the electorate going to the polls on November 6, 1962, will miss the "bargain" of electing two Congressmen of their choice at one election.

By voting for two Congressmen, the voters will have the chance of voting for one representing their Congressional district, and the other to represent them as part of the entire state of Michigan.

There might be some confusion among the voters in thinking that their present Congress-

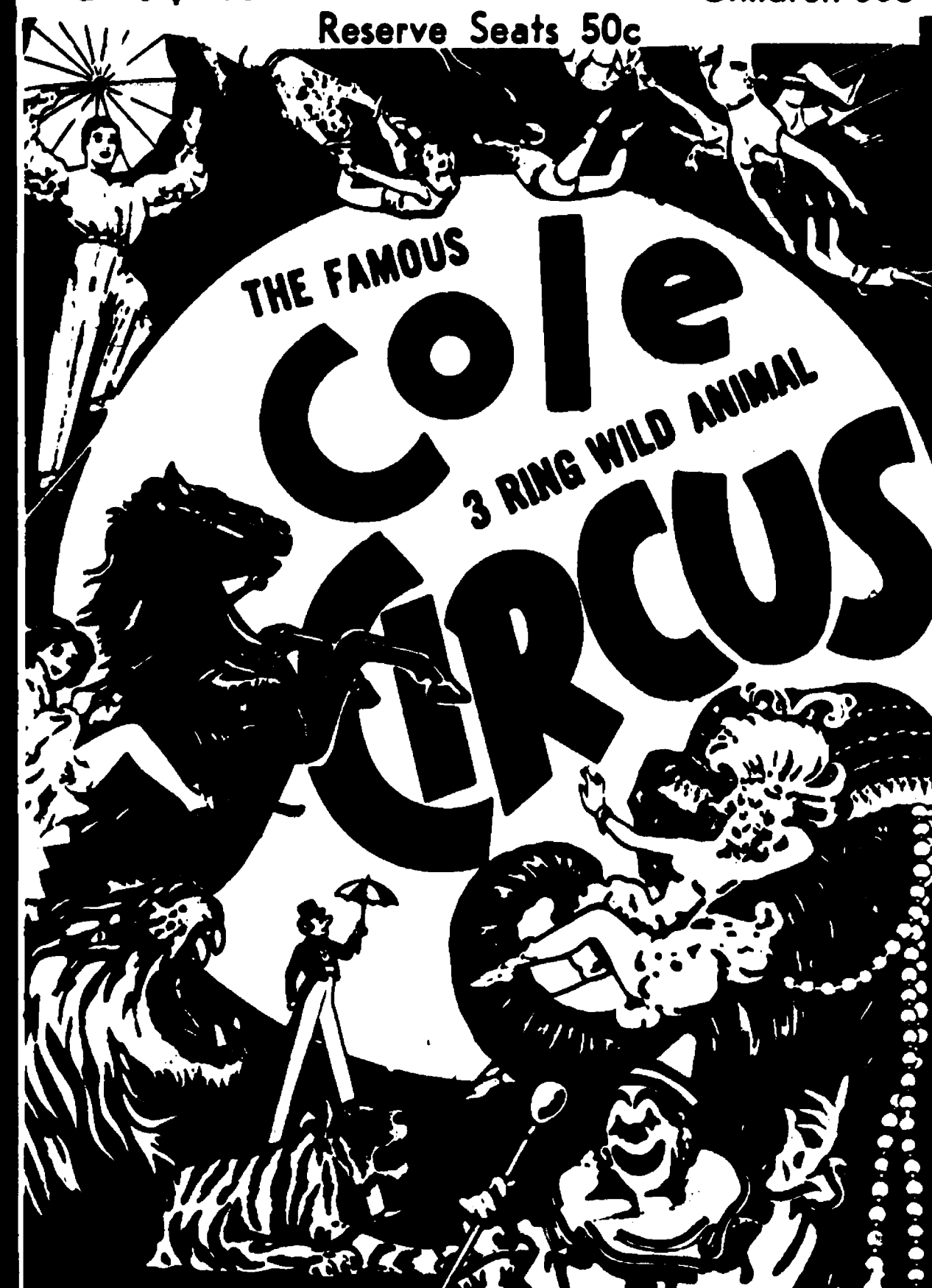

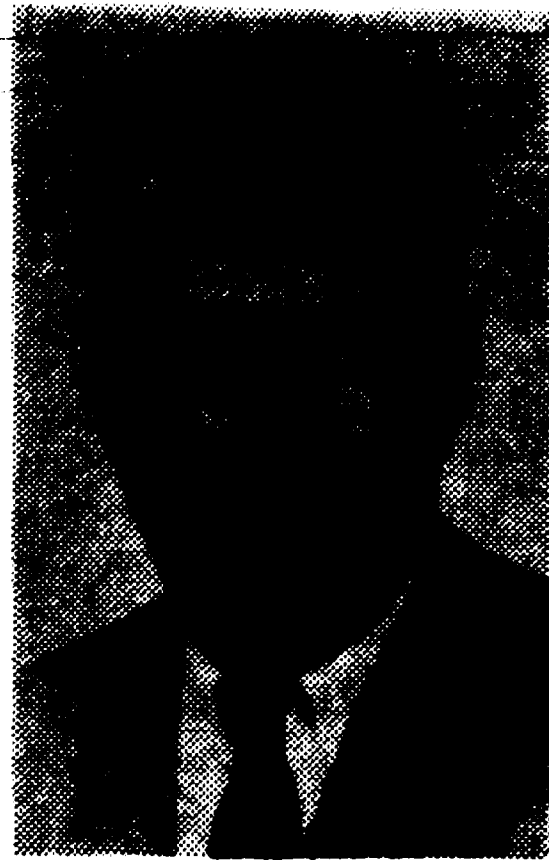

You can identify these vine-ripened beauties by their clean stem ends, high, well-defined, close net and warm beige color. Rich in Vitamin A and a good source of Vitamin C, California Midsummer cantaloupes are remarkably low in calories — only 35 to 40 in an average half-shell serving.

### REGAL FRUIT RING

1 California cantaloupe	1/4 cup lemon juice
1 quart pineapple-grapefruit juice	1/4 teaspoon salt
2 packages (3 oz. each) lemon gelatin	1 basket fresh strawberries

Cut cantaloupe lengthwise into halves. Scoop out seeds; cut into 12 wedges and cut off rind. Heat 2 cups pineapple-grapefruit juice to boiling, and dissolve gelatin in it. Stir in remaining cold juice, lemon juice and salt. Chill until slightly thickened. Coat 2-quart mold with 1/4 cup gelatin. Stand cantaloupe wedges up in mold. Place washed hulled strawberries between cantaloupe slices. Fill center of ring with remaining berries. Spoon gelatin over berries and cantaloupe. If tips of cantaloupe wedges extend above gelatin, trim them off and press into gelatin. Chill until firm. Unmold to serve. If desired, garnish with cantaloupe balls, strawberries and salad greens. Serves 12.
